WHEREAS, the recognition was granted to the institution namely Chikkodi Taluka Education Society's College of Physical Education (B.P.Ed.), C/o. R.D. Composite PU College Campus, Chikkodi Taluk, Belgaum District-591201, Karnataka vide SRC (NCTE) order no. F.SRO/NCTE/B.P.Ed./2004-2005/352 dt. 31.01.2005 for conducting B.P.Ed. course of one-year duration with an annual intake of 50 students from the academic session 2004-2005.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 27.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 20.05.2015 for conducting B.P.Ed. course of two years duration with an annual intake of 100 (one basic unit) from the academic session 2015-16.

AND WHEREAS, the SRC in its 369th meeting held on 28th January 2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institutions on dt. 16.05.2019. The institution did not reply to Show Cause Notice till date.

AND WHEREAS, the SRC in its 388th meeting held on 14th-15th September 2020 considered the matter and decided to issue Final SCN to all the institutions wherein Recognition was accorded by the SRC with the direction to submit all requisite documents. Accordingly, Final Show Cause was issued on 21.10.2020.

AND WHEREAS, the SRC in its 389th Meeting held on 12th & 14th October 2020 considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, as per directed a Final Show Cause Notice was issued to the institution on dt. 16.10.2020. The institution submitted its reply along with documents on dt. 18.11.2020. The institution vide letter 09.11.2020 submitted its reply to the Final Show Cause Notice.

AND WHEREAS, the SRC in its 394th meeting held on 27th-28th January 2021 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee considered the reply submitted by the institution on 09.11.2020 in respect to the Final Show Cause Notice and found the following deficiencies: -

- (i) The institution has submitted photocopy of R.T.C. in the name of Chikodi Taluka Education Society. The institution is required to submit certified copy of land documents.
- (ii) Total Land area is not mentioned in LUC.
- (iii) The name of the trust or institution is not mentioned in the building plan. Seal is in regional language, hence issuing authority is not clear.
- (iv) Multipurpose hall area is not mentioned in the building plan.
- (v) Issuing authority seal is in regional language, hence it is not clear whether BCC is approved or not. Multipurpose hall area is not mentioned in BCC.

- (vi) The institution is required to submit Form "A" issued by the bank manager towards creation of FDR of Rs. 7 lakh & Rs. 5 lakhs towards Endowment Fund & Reserve Fund.
- (vii) Faculty list is not approved by the competent authority.
- (viii) Faculty list is submitted for Seven faculty members, which is not sufficient for 100 students (one basic unit).

Hence, the Committee decided to withdraw the recognition granted to Chikkodi Taluka Education Society's College of Physical Education (B.P.Ed.), C/o. R.D. Composite PU College Campus, Chikkodi Taluk, Belgaum District-591201, Karnataka for conducting B.P.Ed course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Chikkodi Taluka Education Society's College of Physical Education (B.P.Ed.), C/o. R.D. Composite PU College Campus, Chikkodi Taluk, Belgaum District-591201, Karnataka for conducting B.P.Ed. programme of two-year duration with an annual intake of 100 students (1 unit) w.e.f. the next academic session i.e., 2020-2021 onwards.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
