WHEREAS, the recognition was granted to the Sabari College of Education, No. 12 Bharathi Street, Pondicherry- 605001 Vide SRC (NCTE) order No F.SRO/NCTE/M.Ed./2008-09/4419 dt. 30.08.2008 for conducting M.Ed. course of one year duration with an annual intake of 25 students from the academic session 2008-2009.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted an affidavit dated 09.03.2015 for its willingness for adherence of provisions of new Regulations.
- AND WHEREAS, a Revised Provisional Recognition Order was issued to the institution on 30.05.2015 for conducting M.Ed. course of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-2016.
- AND WHEREAS, the matter was further considered by the Committee constituted by the SRC as per its decision taken 369th Meeting held on 28.01.2019 and The Committee of the SRC decided to issue Show Cause Notice to all such institution. Accordingly, a Show Cause Notice was issued to the institution on 24.10.2019 The institution has not submitted reply of Show Cause Notice.
- AND WHEREAS, the matter was further considered by the SRC in its 397th meeting held on 25th - 26th March ,2021 and the Committee decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRCand the following observations were made:-

> A Final Show Cause Notice was issued to the institution on 24.10.2019 the institution has not submitted reply of Final Show Notice.

Hence, the Committee decided to withdraw the recognition granted to Sabari College of Education, No. 12 Bharathi Street, Pondicherry-605001 for conducting B.Ed. & M.Ed. course with effect from the next academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee withdraw the recognition granted to Sabari College of Education, No. 12 Bharathi Street, Pondicherry- 605001 for conducting M.Ed. course with effect from the next academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.
- **7.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
