WHEREAS, recognition u/s14 Act of NCTE, 1993 was granted to the institution namely, Siddartha College of Education, Musunur, Kavali (M), Musunur P.O, Nellore District, Andhra Pradesh-524202 vide order No. F.AP/B.Ed/New/59/SRO/NCTE/2000-2001/1582 dated 14.08.2000 for conducting Secondary (B.Ed.) Course of one year duration with an annual intake of 100 students.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution had consented to come under new Regulations vide a notarized affidavit dated 26.01.2015. A revised provisional recognition order was issued on 06.05.2015 to the institution for conducting B.Ed. programme of two years duration with an annual intake of 150 students (three basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 decided that the Show Cause Notice be issued to all such institution which have not submitted compliance. Accordingly, as per the decision of SRC, a show cause notice was issued to the institution on 30.04.2019. The institution has not submitted reply to the Show Cause Notice.
- **4. AND WHEREAS,** the SRC in its 381st Meeting held on 31st October & 01st November, 2019 decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT report accompanied with the requisite documents. Accordingly, a Final Show Cause Notice issued to the institution on 15.11.2019. The institution has submitted reply on 12.12.2019.
- 5. AND WHEREAS, the SRC in its 410^{th} meeting held on $25^{th} 26^{th}$ April, 2022 has considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC withdrawal order no. F.SRC/NCTE/AOSO0421/B.Ed./AP/2022/132414-132418 dated 07.06.2022 was issued to the institution.
- **6. AND WHEREAS**, aggrieved by the order dated 20.07.2022 of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. 89-189/E-259943/2022 Appeal/9th meeting, 2022 APPLSRC202214412 dated 30.11.2022 appeal remand back the order appealed against. The institution vide letter dated 03.12.2022 submitted reply to the appeal remand back order.

7. **AND WHEREAS**, the SRC in its 418th Meeting held on 16th December, 2022 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Siddartha College of Education, Survey No. 812-1A, 812-1B, Musunuru Village & Panchayat, Kavali Mandal, S.P.S.R., Nellore District, Andhra Pradesh-524202 for B.Ed. programme, 3 basic units of 50 students each."

- 8. NOW THEREFORE, this order is issued permitting the institution i.e., Siddartha College of Education, Survey No. 812-1A, 812-1B, Musunuru Village & Panchayat, Kavali Mandal, S.P.S.R., Nellore District, Andhra Pradesh-524202 for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 3 basic units of 50 students each subject to fulfilment of the following conditions:-
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **9.** Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 10. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- **13.** The institution shall make available the list of students admitted on its official website.
- 14. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
