WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely B.E.S. College of Education, VI Block, Jayanagar, Bangalore-560011, Karnataka vide order no. F.KAR/B.Ed./04/SRO/NCTE/2000-2001/911 dt. 10.07.2000 for conducting B.Ed. course of one year duration from the academic session 2000-2001 with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 20.01.2015 for its willingness for B.Ed. course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 30.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 Students (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the institution has submitted a request letter on 04.01.2016 for granting recognition to their college with an annual intake of one basic unit of 50 students. Thereafter, the request of the institution considered by the SRC in its 301st Meeting held on 05th & 06th February, 2016 and decided to issue corrigendum to the institution. A corrigendum order no. F.SRO/NCTE/APS03408/B.Ed./KA/2016/83377 dt. 05.04.2016 for conducting B.Ed. programme of two years duration with an annual intake of 50 students (one basic unit) form the academic session 2015-16 instead of 100 students (two basic units) was issued.
- 4. AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 has considered the matter and the Committee decided to issue a Show Cause Notice. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 12.02.2019. The institution has submitted a written representation against Show Cause Notice dt. 09.03.2019.
- 5. AND WHEREAS, the SRC in its 376^{th} meeting held on $11^{th} 12^{th}$ June 2019 has considered the matter and the Committee decided to issue a Show Cause Notice. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 17.06.2019. The institution has not submitted any reply against Show Cause Notice.
- 6. AND WHEREAS, the SRC in its 388th Meeting held on 14th & 15th September 2020 has considered the matter and the Committee decided to issue a Final Show Notice to the institution. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 09.10.2020. The institution vide letter dated 26.10.2020 has submitted a reply in response to the Final Show Cause Notice.
- 7. AND WHEREAS, the SRC in its 405^{th} meeting held on $13^{th} 14^{th}$ December 2021 has considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC, a Withdrawal Order No. F.SRO/NCTE/APS03408/B.Ed./{KA}/2021/129834 was issued to the institution on 07.01.2022.
- 8. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-12/E-

235076/2022 Appeal/3rdMeeting, 2022 Appeal No. APPLSRC202114213 dated 18.04.2022 appeal committee of the council concluded to confirm the withdrawal order dated 07.01.2022.

9. AND WHEREAS, the SRC in its 411th meeting held on 23rd - 24th May 2022 has considered the matter and decided as under: -

"The Committee noted the order of the Appellate Authority confirming the withdrawal order issued by the SRC, NCTE. Further the office of the Regional Director, SRC is advised to return the FDRs to the institution by following the prescribed rules and close the file and inform the respective affiliating body/University and the State Govt."

10. AND WHEREAS, the institution has filed Writ Petition before Hon'ble High Court of Delhi bearing W.P (C) No. 13529/2022 & CM APPL. 41188/2022 titled as B.E.S. College of Education versus National Council for Teacher Education & Anr. Whereby the Hon'ble High Court has directed that: -

"Respondents are directed to update the status of Petitioner, within a period of one week from today on their website and send an intimation in respect thereof to affiliating university of Petitioner viz. Bangalore University, Karnataka, as well as to concerned Department of Education to enable them to participate in counselling and admission process for academic session 2022-23."

- 11. AND WHEREAS, in compliance of order dated 26.09.2022, the Regional Director, SRC has already passed an order dated 19.10.2022 vide order no. File No. SRO/NCTE/APSO3408/B.Ed./KA/2022/136419-136421. This is only for confirmation.
- 12. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-12/E-235076/2022 Appeal/8th Meeting, 2022 APPLSRC202114213 dt. 16.11.2022 appeal remand back the order appealed against. The institution has submitted reply of appeal remand back case on 13.12.2022.
- 13. AND WHEREAS, the SRC in its 418th Meeting held on 16th December, 2022 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution B.E.S. College of Education, Survey No. 27, Main Road, 4th Block, Jayanagar, Bangalore-560011, Karnataka for B.Ed. programme for 1 basic unit of 50 students."

14. NOW THEREFORE, this order is issued permitting the institution i.e., B.E.S. College of Education, Survey No. 27, Main Road, 4th Block, Jayanagar, Bangalore-560011, Karnataka run by Bharath Education Society, Survey No. 27, Main Road, 4th Block, Jayanagar, Bangalore-

560011, Karnataka for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 15. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 16. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 17. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - .e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

- 18. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 19. The institution shall make available the list of students admitted on its official website.
- 20. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
