WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely, Roshan B.Ed College, 306/B, Vissapalem Street and Village, Narasaraopet Taluk, Narasaraopet City, Guntur District – 522601, Andhra Pradesh vide order no. F.SRO/SRCAPP172/B.Ed./AP/2015/62232 dt. 03.03.2015 for B.Ed. Programme of two years duration with annual intake of 2 units of 50 students each from the academic sessions 2015-2016.

- 2. AND WHEREAS, the SRC in its 408th Meeting held on 02nd March, 2022 taken a decision to issue Show Cause Notice to all the colleges of teacher education established even after NCTE Regulations, 2014 at the earliest in order to ascertain the compliance of NCTE Regulations, 2014. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 15.11.2022. The institution has submitted its reply on 29.11.2022.
- **3. AND WHEREAS,** the SRC in its 419th Meeting held on 13th January, 2022 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Roshan B.Ed. College, Survey No. 306/B, Issalpalem Village, Narasaraopet Mandal, Narasaraopet City, Guntur District, Andhra Pradesh – 522601 for B.Ed. programme for 2 basic units of 50 students each.

The Committee further decided that the above said decision will be subject to the outcome of writ petition pending before the Hon'ble High Court of Delhi in respect of Performance Appraisal Report (PAR)."

- 4. NOW THEREFORE, this order is issued permitting the institution i.e., Roshan B.Ed. College, Survey No. 306/B, Issalpalem Village, Narasaraopet Mandal, Narasaraopet City, Guntur District, Andhra Pradesh 522601 for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 2 basic units of 50 students each subject to the outcome of writ petition pending before the Hon'ble High Court of Delhi in respect of Performance Appraisal Report (PAR) fulfilment of the following conditions:-
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
