WHEREAS, the recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely, Montessori College of Education, Khasara/Plot No. 153/4B, Street No.1, Nennuru Village & Post, Ramachandrapuram Taluk, Tirupati Rural, Chittoor District – 517505, Andhra Pradesh vide order no. F.No.SRCAPP1747/B.Ed./AP/2012/45928 dt. 06.09.2012 for conducting (B.Ed.) course of one year duration with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted an affidavit dt. 13.02.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 14.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- **3. AND WHEREAS,** the composite inspection was conducted on 4.02.2016. VTR received on 08.02.2016 in D.El.Ed. & B.Ed. Course. The SRC in its 316th meeting held on 07th 08th July, 2016 considered the matter and decided as under:-
 - 1. Land documents is given Title is clear.
 - 2. EC and LUC are clear.
 - 3. BP is in order. BCC is submitted in the allied D.El.Ed. case.
 - 4. According to BP and BCC, the built-up areas is adequate only for one unit each of B.Ed. and D.El.Ed.
 - 5. They have themselves also requested for reduction of B.Ed to 1 unit.
 - 6. Original FDRs and approved Faculty list are not given.
 - 7. Based on the composite inspection, conducted, this case can be cleared for shifting of B.Ed. (1 unit) to D.El.Ed (1 unit) is being run. Withdraw recognition for B.Ed. (2 units) w.e.f. 2016-17. Ask them not to make new admissions in 2016.17.
 - 8. Obtain original FDRs and approved Faculty list before issue to ensure proper adherence to norms.
- **4. AND WHEREAS,** the SRC in its 388th meeting held on 14th 15th September, 2020 considered the matter and decided to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 01.08.2022. The institution has submitted reply on 26.08.2022.
- **5. AND WHEREAS,** the SRC in its 417^{th} meeting held on $01^{st} 02^{nd}$ December, 2022 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 08.12.2022. The institution has submitted reply on 09.12.2022.

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The noted that a composite inspection has been conducted by VT Members on 04.02.2016 for the D.El.Ed. new Course and Shifting for B.Ed. course. The VT has submitted there report on 08.02.2016 to the SRC. The Committee further noted that the SRC in its 316^{th} meeting held on $07^{th} - 08^{th}$ July, 2016 and has decided to reduce from 2 units to 1 unit for B.Ed. course.

The Committee considered the reply dated 09.12.2022 to the Final Show Cause Notice. The Committee further accepted the VT report submitted on 08.02.2016 and shifting of the premisses of the institution is hereby allowed.

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Montessori College of Education, Survey No. 818/2B, 783/1, Pakalavaripalli Village, Panapakam (GP), Chandragiri (Mandal) Chittoor District, Andhra Pradesh-517112 for B.Ed. programme, 1 basic unit of 50 students.

The Committee further decided that the above said decision will be subject to the outcome of writ petition, anding before the Hon'ble High Court of Delhi in respect of Performance Appraisal Report (PAR)."

- 7. NOW THEREFORE, this order is issued permitting the institution i.e., Montessori College of Education, Survey No. 818/2B, 783/1, Pakalavaripalli Village, Panapakam (GP), Chandragiri (Mandal) Chittoor District, Andhra Pradesh-517112 for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students subject to the outcome of writ petition pending before the Hon'ble High Court of Delhi in respect of Performance Appraisal Report (PAR) and fulfilment of the following conditions:-
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 5. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

- 6. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 7. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 8. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 9. The institution shall make available the list of students admitted on its official website.
- 10. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
