WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely, Sri Lakshmi Sravani College of Education, Survey No. 615/B, Medarametla Gram Panchayat, Korisapadu Taluk, Prakasam District – 523212, Andhra Pradesh vide order no. F.SRO/NCTE/SRCAPP2266/B.Ed./AP/2016-17/83607 dt. 05.04.2016 for B.Ed. Programme of two years duration with annual intake of 1 unit of 50 students from the academic sessions 2016-2017.

- 2. AND WHEREAS, the SRC in its 408th Meeting held on 02nd March, 2022 taken a decision to issue Show Cause Notice to all the colleges of teacher education established even after NCTE Regulations, 2014 at the earliest in order to ascertain the compliance of NCTE Regulations, 2014. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 15.11.2022. The institution has submitted its reply on 09.12.2022.
- 3. AND WHEREAS, the SRC in its 418th Meeting held on 16th December, 2022 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Sri Lakshmi Sravani College of Education, Survey No. 615/B, Medarametla Gram Panchayat, Korisapadu Taluk, Prakasam District – 523212, Andhra Pradesh for B.Ed. programme, 1 basic unit of 50 students."

- 4. NOW THEREFORE, this order is issued permitting the institution i.e., Sri Lakshmi Sravani College of Education, Survey No. 615/B, Medarametla Gram Panchayat, Korisapadu Taluk, Prakasam District 523212, Andhra Pradesh for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions:-
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.

III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

- 6. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 7.  - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information if it so desires.
