WITHDRAWAL ORDER

WHEREAS, recognition u/s14 (3)(a) of NCTE Act, 1993 was granted to the institution namely, Smt. MannaruYasodamma Memorial B.Ed. College, Addanki Road, Darsi (P.O & M), Kandukur Revenue Division, Prakasam District, Darsi, Andhra Pradesh-523247 run by Sri Anjani Puthra Educational Society, Prakasam District, Darsi, Andhra Pradesh-523247 for B.Ed. Course Vide SRC (NCTE) Order No. F.AP/NEW/B.Ed./304/SRO/NCTE /2003-2004/9588 dated 13.10.2003 for conducting Secondary B.Ed. Course of one year duration with an annual intake of 100 students form the academic session 2003-2004.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 13.01.2015.
- 3. AND WHEREAS, the SRC in its 287th Meeting held on 20thMay, 2015 considered the VT report and decided as permit shifting to new premises. Therefore, permission is hereby accorded by SRC to Smt. MannaruYasodamma Memorial B.Ed. College, Addanki Road, Darsi (P.O & M), Kandukur Revenue Division, Prakasam District, Darsi, Andhra Pradesh to shift its premises to the new location/building at Smt. MannurYasodamma Memorial B.Ed. College Survey no. 458/1 & 458/3, Addanki Road, 14th Block DarsiPraksam District, Andhra Pradesh-523247 and the provisional revised recognition order was issued on dt. 29.05.2015 to the institution for conducting B.Ed. programme of two years duration with an annual intake of 100 students each for two basic units from the academic session 2015-2016.
- 4. AND WHEREAS, an order vide no. F.SRO/NCTE/APSO1313/B.Ed./AP/2016-17/88690 dt. 07.10.2016 for granting recognition to the institution Smt. MannaruYadodamma Memorial B.Ed. College, Survey no. 458/1 & 458/3, Addanki Road, 14th Block DarsiPraksam District, Andhra Pradesh for running B.Ed. course of two years duration with an intake of 100 students (two units of 50 students each) from the academic session 2016-2017.
- 5. AND WHEREAS, the SRC in its 381st Meeting held on 31st Oct & 01stNov, 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, as per decision of SRC First Show Cause Notice was issued to the institution on 20.11.2019. The institution did not submit any reply to First Show Cause Notice.
- 6. AND WHEREAS, the SRC in its 414th meeting held on 26th & 27th September 2022 considered the matter and committee decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 11.10.2022. The institution has submitted reply of FSCN vide letter dated 07.11.2022.
- 7. AND WHEREAS, the SRC in its 425th Meeting held on 18th May 2023 considered the matter and found some deficiencies in reply to Final Show Cause Notice and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide letter dated 07.11.2022. The Committee perused the reply submitted by the institution and found the following deficiencies.

- The institution has submitted faculty list in which lecturer at S.No. 2,3,4,5,8,9,10,12
 4 13 does not have NET/Ph.D. as per NCTE (Recognition Norms & Procedure)
 (Amendment) Regulations, 2017 dated 29.05.2017 notified on 09.06.2017.
- 2. Further, the institution has failed to submit copies of certificates of academic & professional educational qualification viz. B.Ed. M.Ed., NET, Ph.D etc. and experience certificate of the Principal.
- 3. The institution failed to submit proof of uploaded information of the Website of the institution as required under clause 7(14) (i), 8 (14) and 10 (3) of the NCTE Regulations, 2014.
- 4. The institution has not submitted certified copy of Land Documents.
- 5. The institution has not submitted Land Use Certificate.
- 6. The institution has submitted photocopy of Building Plan but not readable.
- 7. The institution has submitted photocopy of Site Plan but not readable.
- 8. The institution has submitted Building Completion Certificate but not in prescribed format as per NCTE Regulation 2014.

Hence the recognition granted Smt. Mannaru Yasodamma Memorial B.Ed. College, Addanki Road, Darsi (P.O & M), Kandukur Revenue Division, Prakasam District, Darsi, Andhra Pradesh-523247 for B.Ed. programme is withdrawn under Section 17(1) of NCTE Act, 1993. No fresh admissions are permitted now onwards. However, if any student is pursuing B.Ed. programme is allowed to continue till they complete the course. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body shall also be withdrawn.

- 8. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Smt. Mannaru Yasodamma Memorial B.Ed. College, Addanki Road, Darsi (P.O & M), Kandukur Revenue Division, Prakasam District, Darsi, Andhra Pradesh-523247 for conducting B.Ed. Programme of two years duration of 100 students for two basic units. No fresh admissions are permitted now onwards. However, if any student is pursuing B.Ed. programme is allowed to continue till they complete the course. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body shall also be withdrawn.
- 9. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act, 1993: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State

Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

- 10. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
