WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Pragati College of Education, No. 19-1-437/1, Pragati Nagar, Peddapuram, East Godavari District-533437, Andhra Pradesh run by Pragati Educational Society, Kakinada, Andhra Pradesh vide order No. F.SRO/NCTE/APSO8976/B.Ed/2007-2008/13318 dated 23.10.2007 for conducting B.Ed. Course of one-year duration with an annual intake of 100 students from the academic session 2007-2008.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 19.01.2015 and the Revised Provisional Recognition Order(RPRO) was issued to the institution on 06.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 students for two basic units of 50 students each from the academic session 2015-16.
- 3. AND WHEREAS, the SRC issued a Corrigendum vide order no. F.SRO/NCTE/APSO8976 /B.Ed/AP/2015/69678 to institution on 10.05.2015 for one basic unit.
- **4. AND WHEREAS**, the SRC in its  $368^{th}$  meeting held on  $8^{th} 9^{th}$  January 2019 has considered the matter and decided to issue a Show Cause Notice. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 08.01.2019.
- **5. AND WHEREAS,** the SRC in its  $373^{rd}$  meeting held on  $26^{th} 27^{th}$  March 2019 has considered the matter and decided to issue Show Cause Notice. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 08.04.2019.
- 6. AND WHEREAS, the SRC in its 381st meeting held on 31st Oct-01st Nov, 2019 considered the matter and decided to issued SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents I response to RPRO issued by the SRC. Accordingly, a Final Show Cause Notice was issued on 15.11.2019. The institution has not submitted any reply in response to the Final Show Cause Notice.
- 7. **AND WHEREAS,** the SRC in its  $393^{rd}$  meeting held on  $05^{th}-06^{th}$  January 2021 has considered the matter and decided to withdraw the recognition. Accordingly, a withdrawal order was issued to the institution on 08.01.2021.
- 8. AND WHEREAS, the institution has filed Writ Petition No.38113 of 2022 Petition before Hon'ble High Court of Andhra Pradesh at Amravati titled as Pragati College of Education Versus The State of Andhra Pradesh and others. vide order dated 02.12.2022.
- 9. AND WHEREAS, the SRC in its 425<sup>th</sup> meeting held on 18<sup>th</sup> May 2023 considered the matter and decided to issue a Show Cause Notice. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 06.06.2023. The institution has submitted a reply to the Show Cause Notice on 06.06.2023.

**10. AND WHEREAS,** the SRC in its 426<sup>th</sup> meeting held on 23<sup>rd</sup> June 2023 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Pragati College of Education, Survey No. 353/1, 353/1C, Ward No.1, Pragati Nagar, Near Anjaneyaswamy Temple, Peddapuram Municipality, East Godavari District-533437, Andhra Pradesh for B.Ed. programme for 1 basic unit of 50 students".

- 11. NOW THEREFORE, this order is issued permitting the institution i.e. Pragati College of Education, Survey No. 353/1, 353/1C, Ward No.1, Pragati Nagar, Near Anjaneyaswamy Temple, Peddapuram Municipality, East Godavari District-533437, Andhra Pradesh run by Pragati Educational Society, Kakinada, Andhra Pradesh for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions:-
  - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

  The institution shall ensure that the required to time.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 12. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 13. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 14. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. - j. The institution shall be free to post additional relevant information if it so desires.

- 16. The institution shall make available the list of students admitted on its official website.
