WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Sri Ayyappa College of Education, Plot/Khasara No. 94/3, 94/3C, Street No.Kothapalli, Kothapalli Village, Eriguthi Post Office, Gudiyattam Taluk, Vellore District, Pin-635810, TamilNadu run by Sri Ayyappa Educational Trust, Plot No. 94/3, 94/3C, Street No.Kothapalli, Kothapalli Village, Eriguthi Post Office, Gudiyattam Taluk, Vellore District, Pin-635810, TamilNadu vide order No. F.No.SRCAPP1992/B.Ed./TN/2013-14/57336 dated 03.03.2014 for conducting B.Ed. Course of one-year duration with an annual intake of 100 students from the academic session 2014-2015.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 27.01.2015 and the Revised Provisional Recognition Order (RPRO) was issued to the institution on 18.03.2015 for conducting **B.Ed. Programme** of two years duration with an annual intake of 100 students for two basic units of 50 students each from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in 388th Meeting held on 14th & 15th September 2020 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT Report accompanied with requisite documents in respond to RPRO issued by the SRC. Accordingly, as per the decision of SRC, a Show Cause was issued to the institution on 16.08.2021. The institution has not submitted a reply to the Show Cause Notice.
- 4. AND WHEREAS, the SRC in its 405th meeting held on $13^{th} 14^{th}$ December 2021 was considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 24.12.2021. The institution did not submit any reply to the Final Show Cause Notice.
- **5. AND WHEREAS,** the SRC in its 421st meeting held on 10th February 2023 considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC, a Withdrawal Order No.F.SRC/NCTE/SRCAPP1992/B.Ed./TN/2023/141270-141274 was issued to the institution on 21.02.2023.
- **6. AND WHEREAS,** aggrieved by the Withdrawal order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-68/E-298357/2023 Appeal/5thMeeting, 2023 Appeal No.APPLSRC202314581 dated 22.05.2023 appeal remand back the order appealed against. The institution has submitted a reply to the Appeal Remand Back on 14.06.2023 and 22.06.2023.
- 7. **AND WHEREAS**, the SRC in its 426th meeting held on 23rd June 2023 considered the matter and decided as under:-

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Sri Ayyappa College of Education, Survey No. 94/3A, 94/3C, 94/4, Kothapalli Village, Pernambut Union, Gudiyatham Taluk, Vellore District-635810, TamilNadu for B.Ed. programme for 2 basic units of 50 students each".

- 8. NOW THEREFORE, this order is issued permitting the institution i.e. Sri Ayyappa College of Education, Survey No. 94/3A, 94/3C, 94/4, Kothapalli Village, Pernambut Union, Gudiyatham Taluk, Vellore District-635810, TamilNadu run by Sri Ayyappa Educational Trust, Plot No. 94/3, 94/3C, Street No.Kothapalli, Kothapalli Village, Eriguthi Post Office, Gudiyattam Taluk, Vellore District, Pin-635810, TamilNadu for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of 2 basic unit of 50 students each subject to fulfilment of the following conditions:-
 - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **9.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 10. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned.
