WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Adarsh College of Teacher Education, Mahabubnagar DT, Andhra Pradesh (Now Telangana) vide order No. F.AP/NEW/B.ED/134/SRO/NCTE/2002-2003/6093 dated 03.03.2003 for conducting (B.Ed.) Course of one-year duration with an annual intake of 100 students from the academic session 2002-2003.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 20.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 13.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units) 50 students each from the academic session 2015-16.
- 3. AND WHEREAS, the SRC, vide order dated 13.10.2015 accorded Adarsh College of Teacher Education, Mahabubnagar Revenue Division, Venkateshwara Colony, Mahabubnagar District 509002, Andhra Pradesh to shift its premises to new location at Adarsh College of Teacher Education, Plot No. 136/A, Malleboinpally Village & Post, Jadcherla Taluk, Mahabubnagar District-509301, Telangana.
- **4. AND WHEREAS,** on the basis of request, the SRC in its  $342^{nd}$  meeting held on  $5^{th} 6^{th}$  July, 2017 decided for reduction of intake from 2 units to 1 unit. Accordingly, an order was issued to the institution on 09.08.2017 reduction of intake from 2 units to 1 unit.
- 5. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, a Show Cause Notice was issued on 19.02.2019. The institution has not submitted reply to the Show Cause Notice.
- **6. AND WHEREAS**, the SRC in its 414<sup>th</sup> meeting held on 26<sup>th</sup> & 27<sup>th</sup> September, 2022 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 12.10.2022. The institution has submitted reply vide letter dated 29.10.2022.
- 7. **AND WHEREAS**, the SRC in its 422<sup>nd</sup> meeting held on 02<sup>nd</sup> 03<sup>rd</sup> March, 2023 has considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC a withdrawal order no. F.SRC/NCTE/APS00225/B.Ed./TS/2023/141516-141520 dated 23.03.2023 was issued to the institution.

- **8. AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No.89-76/E-300323/2023 Appeal/5<sup>th</sup> Meeting, 2023 dated 22.05.2023 appeal remand back the order appealed against. The institution vide letter dated 29.05.2023 submitted reply to the appeal remand back order.
- 9. AND WHEREAS, the SRC in its 426<sup>th</sup> meeting held on 23<sup>rd</sup> June, 2023 considered the matter and Committee decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Adarsh College of Teacher Education, Survey No. 136, Malleboinpally (GP), Jadcherla (Mdl), Mahabubnagar District, Telangana - 509301 for B.Ed. programme 1 basic unit of 50 students."

- 10. NOW THEREFORE, this order is issued permitting the institution i.e. Adarsh College of Teacher Education, Survey No. 136, Malleboinpally (GP), Jadcherla (Mdl), Mahabubnagar District, Telangana 509301 for continuation of recognition for B.Ed. Programme for two years duration with an annual intake of (1 basic unit) of 50 students subject to fulfillment of the following conditions:-
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 11. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 12. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 13. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for

information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter:
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 14. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 15. The institution shall make available the list of students admitted on its official website.
- 16. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
