WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Rayalaseema College of Physical Education, Rayavaram, Mydukur Road, Proddatur-516362, Andhra Pradesh vide order No. F. B.P.Ed-001/SRO/NCTE/2000-2001/8035 dated 26.09.2001 for conducting B.P.Ed. Course of one-year duration with an annual intake of 70 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution submitted affidavit for its willingness & adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 31.05.2015 for conducting B.P.Ed. Programme of two years duration with an annual intake of 100 (two section of 50 students each) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 413th meeting held on 22nd & 23rd August 2022 took note about the institution who have filled the PAR with certain deficiencies. In view of the above decision, the Regional Committee advised the Regional Director, SRC to issue Show Cause Notice to all such institution seeking infrastructure and instructional details along with GIS location at the earliest. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 23.01.2023. The institution vide dated 29.04.2023 has submitted a reply to the Show Cause Notice.
- **4. AND WHEREAS**, the SRC in its 425th meeting held on 18th May 2023 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Rayalaseema College of Physical Education, Survey No. 248/5, 246/2, 245/6, 242/4, 249, 111/1 & 148, Kotha Pally Panchayath, Thallamapuram Panchayath Rayavaram, Mydukur Road, Proddatur, Kadapa District, Andhra Pradesh-516362 for B.P.Ed. programme for 1 basic unit of 100 students."

5. NOW THEREFORE, this order is issued permitting the institution i.e. Rayalaseema College of Physical Education, Survey No. 248/5, 246/2, 245/6, 242/4, 249, 111/1 & 148, Kotha Pally Panchayath, Thallamapuram Panchayath Rayavaram, Mydukur Road, Proddatur, Kadapa District, Andhra Pradesh-516362 for continuation of recognition for B.P.Ed. - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
