WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Sri Srinivasa College of Education, H.No.10/7486, Sitaramanagar, Koilkuntla, Kurnool-518134, Andhra Pradesh run by Srinivasa Educational Society, Kurnool District, Andhra Pradesh vide order No. F. SRO/NCTE/B.Ed./2006-2007/2402 dated 10.05.2007 for conducting Secondary (B.Ed.) Course of one-year duration with an annual intake of 100 students.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution submitted affidavit dated 27,01.2015 for its willingness & adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 19.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- AND WHEREAS, the SRC in its 329th meeting held on 06th 07th February 2017 has 3 considered the matter and decided to issue a letter. Accordingly, as per the decision of SRC, a letter was issued to the institution on 01.03.2017. The institution has not submitted a reply to the letter.
- AND WHEREAS, the SRC in its 393rd meeting held on 05th 06th January 2021 has 4. considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 08.01.2021. The institution vide letter dated 01.02.2021 has submitted a written representation and partial reply to the Final Show Cause Notice.
- AND WHEREAS, the SRC in its 395th held on 25th 26th February 2021 has considered the 5. matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC, a withdrawal order No.F.SRO/NCTE/APSO7395/AP/B.Ed./2021/124409-124416 was issued to the institution on 08.03.2021.
- AND WHEREAS, the institution has filed Writ Petition before Hon'ble High Court of Delhi for bearing W.P (C) No. 9212/2022 & CM APPLs.43713/2022 titled as Sri Srinivasa College of Education Versus National Council for Teacher Education Whereby the Hon'ble High Court. In compliance of order dated 02.11.2022, the Regional Director, SRC has already passed an order dated 11.11.2022 vide order no. File No.SRO/NCTE/APSO7395 /B.Ed./AP/2022/136676-136678.
- AND WHEREAS, the institution vide letter dated 27.11.2022.2022 has submitted a reply in response to the Court order in bearing W.P (C) No. 9212/2022 & CM APPLs.43713/2022, dated 02.11.2022.
- AND WHEREAS, the SRC in its 417th meeting held on 01st 02nd December 2022 considered the matter and decided to issue a Letter to the institution asking them to submit latest faculty list duly approved by the Affiliating University. Accordingly, as per the decision of SRC, a letter was issued to the institution on 12.12.2022. The institution has submitted vide letter dated 29.04.2023.

10. AND WHEREAS, the SRC in its 425th meeting held on 18th May 2023 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made:

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Sri Srinivasa College of Education, Survey No. 167 & 170, 10th Ward, OWK Road, Sitaramanagar, Koilkuntla (V&M), Kurnool-518134, Andhra Pradesh for B.Ed. programme - 1 basic unit of 50 students."

- 11. NOW THEREFORE, this order is issued permitting the institution i.e. Sri Srinivasa College of Education, Survey No. 167 & 170, 10th Ward, OWK Road, Sitaramanagar, Koilkuntla (V&M), Kurnool-518134, Andhra Pradesh for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of (1 basic unit) of 50 students subject to fulfilment of the following conditions:-
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 12. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 13. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 14. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- 15. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 16. The institution shall make available the list of students admitted on its official website.
- 17. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
