WHEREAS, the recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Sree Bhavani College of Education, Plot/Khasara No. 121, 2A, 3, 4,5 122/2, Plot No. 125/4A, K. Kothanur Village, Nallur Post Office, Virudhachalam Taluk Cuddalore District-606302, Tamilnadu run by Sree Sakthi Vinayaga Trust, Plot No. 125/4A, K. Kothanur Village, Nallur Post Office, Virudhachalam Taluk Cuddalore District-606302, Tamilnadu vide order No. F. SRO/NCTE/SRCAPP1924/B.Ed./TN/2015-2016/64426 dated 12.05.2015 for conducting B.Ed. programme of two-years duration with an annual intake of 100 students from the academic session 2015-2016.

- 2. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per SRC decision a Show Cause Notice was issued to the institution on 24.09.2019. The institution has submitted reply of Show Cause Notice vide letter dated 16.10.2019.
- 3. AND WHEREAS, the SRC in its 409^{th} meeting held on $28^{th}-29^{th}$ March 2022 considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 19.04.2022. The institution vide letter dated 04.07.2022 has submitted a reply to the Final Show Cause Notice.
- 4. AND WHEREAS, the SRC in its 423rd meeting held on 12th April 2023 considered the matter and committee decided to issue Late Reminder Letter. Accordingly, as per the decision of SRC a Last Reminder Letter was issued to the institution on 21.04.2023. The institution has submitted reply of Last Reminder Letter vide letter dated 21.04.2023.
- 5. AND WHEREAS, the SRC in its 425th meeting held on 18th May 2023 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Sree Bhavani College of Education, Survey No. 125/4A, K.Kothanur Village, Nallur Post, Virudhachalam Taluk Cuddalore District-606302, Tamilnadu for B.Ed. programme - 2 basic units of 50 students each."

- 6. NOW THEREFORE, this order is issued permitting the institution i.e. Sree Bhavani College of Education, Survey No. 125/4A, K.Kothanur Village, Nallur Post, Virudhachalam Taluk Cuddalore District-606302, Tamilnadu for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of (2 basic unit) of 50 students each subject to fulfilment of the following conditions:-
 - 1. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 7. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- **8.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 9. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;

i. The affidavit with enclosure submitted along with application.

j. The institution shall be free to post additional relevant information if it so desires.

k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

10. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

11. The institution shall make available the list of students admitted on its official website.

12. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
