WITHDRAWAL ORDER

WHEREAS, recognition u/s14(3)(a) of NCTE Act, 1993 was granted to the institution namely, Adarsh College of Teacher Education, Mahabubnagar District. Andhra Pradesh vide Order No. F.AP/NEW/B.ED/134/SRO/NCTE/2002-2003/6093 dated 03.03.2003 for conducting B.Ed. Course of one year duration with an annual intake of 100 students from the academic session 2002-2003.

- AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 20.01.2015 and the Revised Provisional Recognition Order(RPRO) was issued to the institution on 13.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 students for two basic units from the academic session 2015-16.
- AND WHEREAS, the SRC in its 342nd meeting held on 05th 06th July 2017 considered the matter and decided to reduction of strength from 2 units to 1 unit on request institution. Accordingly, per the decision of SRC, No.F.No.SRO/NCTE/APS00225/B.Ed./TS/2017-18/94307 dated 09.08.2017 was issued for reduction of intake from 2 units to 1 unit.
- AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice issued on 19.02.2019. The institution was not submitted any reply to the Show Cause Notice.
- 5. AND WHEREAS, the SRC in its 414th Meeting held on 26th - 27th September 2022, considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC. a Final Show Cause Notice was issued to the institution on 12.10.2022. The institution vide letter dated 29.10.2022 has submitted a reply to the Final Show Cause Notice.
- AND WHEREAS, the SRC in its 422nd Meeting of SRC held on 02nd 03rd March 2023 considered the matter of reply to Final Show Cause Notice and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines Issued by NCTE from time to time and

documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide letter dated 29.10.2022. The Committee perused the reply submitted by the institution and found the following deficiencies.

- 1. The institution has submitted all the documents regarding land & building in photocopy without any attestation.
- 2. The institution has submitted a Building plan in which Multi-purpose Hall Area is not sufficient as per NCTE Norms.
- 3. The institution did not submit an original affidavit and Form 'A'.
- 4. The bank statement shown the name as "Mohammed Rafiq" and as per approved faculty list the name shown as "Mohd. Ilyas". The institution is required to submit an Affidavit on Rs.100/- Non-Judicial Stamp paper clearly mentioning the name and account number of each of the faculty appointed for B.Ed. programme and also stating therein that the faculty are being paid salary through cheque/RTGS/NEFT. The Affidavit should be supported with documents like photocopy of passbook of each of faculty showing the disbursement of salary through bank account to individual faculty members (at-least for 3 months).

Hence the recognition granted Adarsh College of Teacher Education, Mahabubnagar District, Telangana-509002 for B.Ed. programme is withdrawn under Section 17(1) of NCTE Act, 1993. No fresh admissions are permitted now onwards. However, if any student is pursuing B.Ed. programme is allowed to continue till they complete the course. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body shall also be withdrawn".

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Adarsh College of Teacher Education, Mahabubnagar District, Telangana-509002 for conducting B.Ed. Programme of two years duration of 50 students for one basic unit. No fresh admissions are permitted now onwards. However, if any student is pursuing B.Ed. programme is allowed to continue till they complete the course. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body shall also be withdrawn.
- 8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act, 1993: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education

immediately before the appointed day falls or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

(8. इसके अलावा, संस्था और संबद्ध निकाय को एनसीटीई अधिनियम, 1993 की धारा 17(4) के निम्निलिखित प्रावधानों के बारे में सूचित किया जाता है: -

"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमति प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")

- 9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
