WHEREAS, recognition u/s 14 Act of NCTE, 1993 was granted to the institution namely, Guthokonda Sreeramulu College of Education, Guthokonda Sreeramulu Education, Ramachandrapuram, Budchiraddypalem, Nellore, Andhra Pradesh-524305 vide order no. F.SRO/NCTE/B.Ed./2006-2007/670 dt. 12.04.2007 for conducting Secondary (B.Ed.) course of one year duration with an annual intake of 100(Hundred) students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 21.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, a corrigendum was issued to the institution vide order no. F.SRO/NCTE/APSO7006/B.Ed./AP/2015/68395 dt. 25.06.2015 for grants recognition to Guthokonda Sreeramulu College of Education, Guthokonda Sreeramulu Education, Ramachandrapuram, Buchiraddypalem, Nellore 524305, Andhra Pradesh for conducting B.Ed. Programme of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-2016.
- 4. AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 04.02.2019. The institution has submitted reply received on 14.03.2019.
- 5. AND WHEREAS, the SRC in its 381st Meeting held on 31st October & 01st November 2019 decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT report accompanied with the requisite documents. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 13.11.2019. The institution did not submit any reply to Final Show Cause Notice.
- 5. AND WHEREAS, the SRC in its 413th Meeting held on 22nd & 23rd August, 2022 considered the matter and decided as under:

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

(i) The institution failed to submit reply to the Final Show Cause Notice dated 13.11.2019.

(ii) Further it is also observed that the institution has not filled Performance Appraisal Report (PAR)

Hence, the recognition granted to Guthokonda Sreeramulu College of Education, Guthokonda Sreeramulu Education, Ramachandrapuram, Buchiraddypalem, Nellore – 524305, Andhra Pradesh for B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the end of next academic session i.e., 2023-2024. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn."

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby agreed to close down the institution by withdrawing recognition granted to Guthokonda Sreeramulu College of Education, Guthokonda Sreeramulu Education, Ramachandrapuram, Buchiraddypalem, Nellore 524305, Andhra Pradesh run by Sri Venkateswara Educational Society, Prathipati Nilayam Wood Nagar, Chirala, Prakasam District, Andhra Pradesh-523155 for conducting B.Ed. programme of two years duration with an annual intake of 50 students (1 basic unit) with effect from the next academic session i.e., 2023-2024 onwards.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
