**WITHDRAWAL ORDER**

**WHEREAS**, the recognition u/s 14 of NCTE Act. 1993 was granted to the institution namely **Smt. A.K.D Sakkaniamma College of Education for Women, No. 160/3, Shendagathottu Road, Rajaalayam-626117, Virudhunagar District, Tamilnadu** run by **A.K.D Dharma Raja Educational Charity Trust, Virudhunagar District, Tamilnadu** vide SRC (NCTE) order F.SRO/NCTE/B.Ed./2006-2007/9712 dated 23.12.2006 for conducting Secondary B.Ed. Course of one-year duration with an annual intake of 100 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution had submitted affidavit dated 24.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 30.04.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 (two basic units 50 students each) from the academic session 2015-16.

3. **AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice issued on 16.08.2019. The institution has submitted reply of Show Cause Notice vide letter dated 18.09.2019.

4. **AND WHEREAS**, the SRC in its 411<sup>th</sup> meeting held on 23<sup>rd</sup> – 24<sup>th</sup> May 2022 has considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 04.06.2022. The institution vide dated 23.06.2022 has submitted a reply to the Final Show Cause Notice.

5. **AND WHEREAS**, the SRC in its 413<sup>th</sup> Meeting held on 22<sup>nd</sup> & 23<sup>rd</sup> August 2022 considered the matter and decided as under:-

*"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -*

*The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its vide dated 23.06.2022. The Committee perused the reply submitted by the institution and found the following deficiencies.*

1. *The institution has submitted a self-attested copy of faculty list not approved by the affiliating university consisting of one Principal and 5 Assistant Professors which are not sufficient as per NCTE Norms for 2 basic units.*
2. *The institution has submitted a photocopy of Land Use Certificate in which Land area and purpose of use is not mentioned in the certificate.*
3. *The institution has submitted Building Plan not approved by competent authority and built-up area is not sufficient for B.Ed. 2 basic units.*
4. *The institution has submitted photocopy of Building Completion Certificate in which date of inspection not mentioned and built-up area not sufficient for B.Ed. 2 basic units and mismatched with building plan.*

*Hence the recognition granted to Smt. A.K.D Sakkaniamma College of Education for Women, No. 160/3, Shendagathottu Road, Rajaalayam-626117, Virudhunagar District, Tamilnadu for B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the end of next academic session i.e. 2023-2024. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn."*

6. **NOW, THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **Smt. A.K.D Sakkaniamma College of Education for Women, No. 160/3, Shendagathottu Road, Rajaalayam-626117, Virudhunagar District, Tamilnadu** run by **A.K.D Dharma Raja Educational Charity Trust, Virudhunagar District, Tamilnadu** for conducting B.Ed. programme of two-year duration with an annual intake of 100 students (two basic units 50 each) for B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the end of next academic session i.e. **2023-2024**. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

**"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College**

**or other Educational Body aided by the Central Government or any State Government."**

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
