WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Malineni Lakshmaiah B.Ed. College, Kanumalla (Village & Post), Singarayakonda Mandal, Prakasam District-523101, Andhra Pradesh run by Malineni Perumallu Educational Society, Prakasam District, Andhra Pradesh vide order no. F.SRO/NCTE/B.Ed./2007-2008/8601 dt. 22.08.2007 for conducting secondary B.Ed. course of one year duration with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 28.01.2015 for its willingness of one unit in B.Ed. course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 20.03.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 50 Students each (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 08.04.2019. The institution vide has not submitted its reply in response to the Show Cause Notice. The institution did not submit any reply to the Show cause Notice.
- **4. AND WHEREAS,** the SRC in its 394<sup>th</sup> meeting held on 27<sup>th</sup> 28<sup>th</sup> January, 2021 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 04.03.2021. The institution has submitted a reply on 09.03.2021.
- **5. AND WHEREAS,** the SRC in its 397<sup>th</sup> meeting held on 25<sup>th</sup> 26<sup>th</sup> March 2021 considered the matter and committee decided to issue continuation order. Accordingly, as per the decision of SRC a continuation order No. SRC/NCTE/APS06281/B.Ed./AP/2021/125498-5505 was issued to the institution on 07.04.2021 for two basic units.
- **6. AND WHEREAS,** the institution vide letter dated 19.06.2023 submitted application for shifting premises along with DD No.483727 Rs. 150000/- along with relevant documents.
- 7. AND WHEREAS, the SRC in its 426<sup>th</sup> meeting held on 23<sup>rd</sup> June 2023 considered the matter and committee decided to constitute the online Visiting Team. The Online VT constituted vide dated 26.09.2023 & 27.09.2023.
- **8. AND WHEREAS,** the SRC in its 429<sup>th</sup> meeting held on 11<sup>th</sup> October 2023 has considered the VT report and decided as under:-
