## PREAMBLE

The institution has submitted application on 19.07.2004 for grant of recognition for B.Ed course. On scrutiny of application following deficiencies were observed

- NOC / Endorsement issued by the state Government / UT Administration.
- Fixed Deposit Receipt in original for Rs 5,00,000 towards endowment fund.
- Application is belated for the session 2004-05

Accordingly the deficiency letter was issued on 08.09.2004

The institution filed Writ Petition No.12528 of 2004 before the Hon'ble High Court of Judicature, Andhra Pradesh at Hyderabad. The court has disposed the case as per the directions in WPNo.10653 of 2004 in which the court has directed to consider the application of the petitioner for recognition, according to law, and pass appropriate orders the thereon keeping in view of the directions of the apex Court in St Johns Teacher Training Institute case.

As per the direction of court to consider the application, a Visiting Team was sent to the institution on 22,05,2005. The Visiting Team Report was placed before SRC in its 94th meeting held on 24.06.2005. In obedience of the Hon'ble High Court of Andhra Pradesh with respect to WP. No 10653 of 2004, SRC approved to accord recognition for B.Ed programme with intake of 100, subject to outcome of any directions from the count in this regard, based on writ appeal of the state Government.

## ORDER

in terms of Section 14(1) of the NCTE Act, 1993 Shams-UI-Uloom College of Education, Podili GramPanchayat, Podili Mandal, Prakasam District, Andhra Pradesh had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for starting B.Ed. Course of One year duration from the academic session 2004-05 with an annual intake of 100 students.

- 2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:
  - The institution has acquired the land for setting up the teacher education 1)
  - The institution has constructed the building for conducting the course on the above 11) mentioned land.

- The institution has created an Endowment Fund of Rs.5.00 lakhs and a Reserve Fund of Rs. 3,00,000/-
- iv) The institution has selected the Principal / Head and 7 teachers for the said course.
- 3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to Shams-Ul-Uloom College of Education, Podili GramPanchayat, Podili Mandal, Prakasam District, Andhra Pradesh for B.Ed. Course of One year duration from the academic session 2004-2005 with an annual intake of 100 students subject to fulfillment of the following:
  - a) The institution will ensure that <u>Principal and 07</u> faculty members are in position for an intake of <u>100</u> students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee within one month of commencement of the course.
  - b) The institution shall, within three months of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Southern Regional Committee.
  - c) The institution shall shift to its own premises within three years from the date of recognition (In case the course is started in rented premises).
  - d) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations and the institution shall be visited on any day after three months from the date of issue of recognition order for ensuring its satisfactory performance.
- 4. That the recognition granted from the session 2004-05 is subject to the condition of admissions through EdCET of Andhra Pradesh State Government.
- The recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc.
- 6. Further, the recognition is subject to the outcome of directions, if any issued by the court issued in the writ appeal filed by the state Government in this regard.

- 7. The institution shall submit to the Southern Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affillating University / State Directorate of Education to the appointment of faculty-members, and the statement of annual accounts duly audited by a Chartered Accountant
- 8. If the institution contravenes any of the above condition or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Southern Regional Committee may withdraw the recognition under the Provisions of Section 17(1) of the NCTE
