WHEREAS, the recognition was granted to Athivetti Karumuthuvalli Teacher Training Institute, 257/3, Trichy Main Road, Vallam Post, Thanjavur Taluk and District 613403, Tamil Nadu for D.T.Ed. course F.TN/SEC/SRO/NCTE/2005-2006/5291 dt.31.01.2006 of two years duration from the academic session 2005-2006 with an annual intake of 50 students.

WHEREAS, the recognition was granted to Athivetti Karumuthuvalli Teacher Training Institute, 257/3, Trichy Main Road, Vallam Post, Thanjavur Taluk and District 613403, Tamil Nadu for D.T.Ed. (Additional Intake) course vide order no. F.TN/SRO/NCTE/D.T.Ed.-AI/2007-2008/19078 dt.28.03.2008 of two years for an additional intake of 50 students.

AND WHEREAS, the institution vide its letter dt 18.01.2021 requesting for closure of the D.T.Ed and D.T.Ed-AI courses.

AND WHEREAS, the matter was placed before the SRC in its 394th meeting held on 27th - 28th January, 2021 considered and decided as the following grounds:

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:

The Committee agreed to close down the institution as requested by the management by its letter dt 18.01.2021 by withdrawing the recognition granted to Athivetti Karumuthuvalli Teacher Training Institute, 257/3, Trichy Main Road, Vallam Post, Thanjavur Taluk and District 613403, Tamil Nadu for conducting D.T.Ed & D.T.Ed-AI courses under clause 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- a) NOC from the affiliating body.
- b) NOC from the staff/faculty.
- c) Resolution of the management to the effect for closure of the course."

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Marudupandiyar Teacher Training Institute, No. 257/4A, Trichy Main Road, Vallam Post, Vellore, Thanjavur District – 613403, Tamilnadu run by Athivetty Karumuthivalli Educational and Charitable Trust, Thanjavur District, Tamilnadu for conducting D.Ed./D.El.Ed-Al course of two years duration with an annual intake of 50 (D.T.Ed) & 50 (D.T.Ed.-Al) students w.e.f. next academic session 2021-2022 onwards.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an appeal u/s 18 of the NCTE Act, 1993, through "Online mode" available on NCTE's website www.ncte-india.org, within 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
