WITHDRAWAL ORDER

WHEREAS, the recognition was granted to **Sri Ram Nallamani Yadava College of Education, 46/1, 44/1B, 45/1, 2B, 29/2, 34/7, 6, 44/2A, 2B, 2C, 34/5, Nallamani Nagar, Kodikurichi, Tenkasi, Tamil Nadu – 627804** for B.Ed. course vide order no. F.TN/SEC/SRO/NCTE/2005-2006/5131 dt.06.01.2006 of one-year duration with an annual intake of 100 students; for B.Ed.-AI course vide order no. F.SRO/NCTE/B.Ed.-AI/2008/7330 dt.25.11.2008 of one-year duration with an annual intake of 100 students; for M.Ed. course vide order no. F.SRO/NCTE/M.Ed./2007-2008/1776 dt.26.05.2008 of one year duration with an annual intake of 25 students. The enhancement of intake of 10 seats from existing 25 to 35 for M.Ed. Course on 30.07.2010 with effect from the session 2010-2011.

AND WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the NCTE Act, 1993 (73 of 1993) the NCTE (Recognition Norms and Procedure), Regulations, 2014 were notified on 01.12.2014 in supersession of the NCTE (Recognition Norms and Procedure), Regulations, 2009.

AND WHEREAS, after the promulgation of NCTE Regulations, 2014 and as per affidavits submitted by the institution dt. 22.01.2015, the provisional revised recognition order was issued to the institution on 30.06.2015 for conducting B.Ed. course and in respect of B.Ed. (Additional Intake) course of two years duration with an annual intake of 100 (two units) from the academic session 2015-16 and in respect of M.Ed. course affidavit submitted by the institution on dt. 22.01.2015 and the Revised Provisional Revised Recognition Order was issued to the institution on 29.06.2015 for conducting M.Ed. course of two years' duration with an annual intake of 50 students (one unit) from the academic session 2015-2016.

AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 and Committee decided that Show Cause Notice be issued to all such institution which have not submitted compliance. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 30.04.2019 (M.Ed) & 15.02.2019 (B.Ed). The institution has not submitted any reply in respect of Show Cause Notice.

AND WHEREAS, the above matter was placed before the SRC in its 388th meeting held on 14 – 15 September 2020. The Committee considered the matter and decided as under: -

"The email received from the Registrar, TNTEU Chennai dt 11.02.2020, the Committee resolved to serve Final Show Cause Notice to all the institution informing the reasons foot forth by the university for each college"

Accordingly, the institution was issued a Final Show Cause Notice (FSCN) dated 10.08.2020 but the institution did not submit its reply.

*In view of the COVID Pandemic the Committee advised the office of the RD, SRC to write a letter to the Institution asking therein to submit the documents asked in **Final Show Cause Notice dt 10.08.2020** within 30 days from the issue of the letter."*

AND WHEREAS, a Final Show Cause Notice was issued to the institution on 21.09.2020 in B.Ed. and M.Ed. courses. The institution has submitted its reply on 02.11.2020.

AND WHEREAS, the matter was placed before the SRC in its 394th meeting held on 27th – 28th January, 2021 considered and decided as the following grounds:

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:

The Committee considered the reply submitted by the institution on 02.11.2020 in respect to the Final Show Cause Notice and found the following deficiencies: -

1. The institution was granted recognition in B.Ed course on temporary premises with a condition to shift to own permanent building within a period of 3 years from the date of recognition granted. However, the documents submitted by the institution stating that the institution has already shifted to own permanent premises without taking prior permission from SRC, NCTE.
2. The institution has submitted Building Plan which is not approved by the competent authority. The size of the Total Built Up area is not adequate for running 4 basic units of B.Ed and 1 unit of M.Ed as per NCTE Regulations, 2014. The size of Multipurpose Hall is also not adequate.
3. The institution has submitted approval letters for B.Ed & M.Ed courses. The institution has submitted 26 Assistant Professors, 1 Physical Director and 2 Principal against the requirement of 1 Principal, 30 Assistant Professors, 2 Associate Professors, 2 Professors, 1 Physical Director, 1 Performing Arts and 1 Fine Arts for 4 Basic Units of B.Ed and 1 unit of M.Ed as per NCTE Regulations, 2014. The institution has submitted proforma of the staff wherein the date of appointments are not shown of the faculty for B.Ed course.

4. The institution has not submitted notarized English version of latest Non-Encumbrance Certificate duly issued by the competent authority. The institution has not submitted Land Use Certificate duly approved by the competent authority. However, the institution has submitted Land Title Certificate which is not approved by the competent authority.
5. The institution has not submitted Form A issued by the respective Branch Manager towards maintenance of Endowment and Reserve Funds for both the courses in joint account with a period of 5 years. The institution has submitted photocopy of FDRs which are already expired.
6. The institution has not submitted BCC in prescribed format. The size of the multipurpose hall is not mentioned. The BCC submitted by the institution is not approved by the competent authority.

Hence, the Committee decided to **withdraw the recognition** granted to **Sri Ram Nallamani Yadava College of Education, 46/1, 44/1B, 45/1, 2B, 29/2, 34/7, 6, 44/2A, 2B, 2C, 34/5, Nallamani Nagar, Kodikurichi, Tenkasi, Tamil Nadu – 627804** for conducting B.Ed, B.Ed-AI & M.Ed courses w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.”

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby **withdraws recognition of Sri Ram Nallamani Yadava College of Education, 46/1, 44/1B, 45/1, 2B, 29/2, 34/7, 6, 44/2A, 2B, 2C, 34/5, Nallamani Nagar, Kodikurichi, Tenkasi, Tamil Nadu – 627804 for B.Ed. course vide order no. F.TN/SEC/SRO/NCTE/2005-2006/5131 dt.06.01.2006 of one-year duration with an annual intake of 100 students; for B.Ed.-AI course vide order no. F.SRO/NCTE/B.Ed.-AI/2008/7330 dt.25.11.2008 of one-year duration with an annual intake of 100 students; for M.Ed. course vide order no. F.SRO/NCTE/M.Ed./2007-2008/1776 dt.26.05.2008 from the next academic session starts after issuance of this order.**

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

“If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government.”

Further, if the institution is not satisfied with the Order, it may prefer an appeal u/s 18 of the NCTE Act, 1993, through "Online mode" available on NCTE's website www.ncte-india.org, within 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
