WHEREAS, the recognition was granted to the institution namely S.K.B. College of Education, Pudur village, Kunnavalasm Poost, Tiruvallur – 631210, Tamil Nadu run by S. K. B. Educational Trust, Kunnavalam Post Thiruvallur – 631201, Tamil Nadu vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2006-2007/7306 dt. 30.08.2006 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2006-2007.

AND WHEREAS, a notice was issued to the institution on 23.07.2010 to submit the documents for the shifting of the premises. The institution submitted its reply on 01.09.2010. The committee considered the matter in its 196th meeting held on 15th-16th September 2010 and decided to cause inspection for shifting of premises. The inspection of the institution was carried on 19.11.2010. The Committee in its 199th meeting held on 22nd-23rd December 2010 considered the VT Report and decided to serve Show Cause Notice to the institution. Accordingly, Show Cause Notice was issued to the institution on 02.02.2011. The institution has submitted its reply vide letter dated 28.02.2011.

AND WHEREAS, the committee in its 202nd meeting held on 14th-15th March 2011 has decided to issue Final Show Cause Notice to the institution. Accordingly, Final Show Cause Notice was issued to the institution on 11.04.2011. The institution has submitted its reply vide letter dated 09.05.2011. The reply of the management to the Final Show Cause Notice was considered in its 205th meeting held on 18th – 19th May 2011. The reply of the institution was not convincing and hence unsatisfactory. On the base of the reply submitted by the institution the Committee decided to withdraw the recognition granted to the institution for conducting B.Ed course. Accordingly, a Withdrawal order was issued to the institution on 28.06.2011. The institution preferred an appeal and the Appeal Committee vide its order dt 28.10.2011 Reversed the order appealed against.

AND WHEREAS, the SRC in its 214th meeting held on 28th November 2011 considered the Appellate Authority's order dt 28.10.2011 and decided to restore the recognition of the institution. Accordingly, an order of restoration of the recognition was issued to the institution on 23.12.2011.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 20.05.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 27.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 and Committee decided that Show Cause Notice be issued to all such institution which have not submitted compliance. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 30.04.2019. The institution has not submitted any reply in respect of Show Cause Notice. The SRC in its 384th meeting held on 12th-13th February 2020 considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, a Final Show Cause Notice was issued on 10.08.2020. The institution has not submitted any reply till date. The Committee may please see that the institution had not submitted replies of Show Cause Notice dt 30.04.2019 (RPRO) and Final Show Cause Notice dt. 10.08.2020 (Lapses in affiliation).

AND WHEREAS, the matter was placed before the SRC in its 388th meeting held on 14 – 15 September 2020 and decided to issue letter to the institution. Accordingly, a letter was issued to the institution on 21.09.2020. The institution has submitted its reply on 16.09.2020.

AND WHEREAS, the SRC in its 394th meeting held on 27th-28th January 2021 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee considered the reply submitted by the institution on 16.09.2020 in respect to the Final Show Cause Notice and found the following deficiencies:

- (i) The institution has not submitted notarized english version of Latest Non-Encumbrance Certificate duly issued by the competent authority.
- (ii) The institution has not submitted original blueprints of the Building Plan. The institution submitted Building Plan wherein the Multipurpose Hall size is not reflecting.
- (iii) The institution has not submitted Latest staff List in prescribed format duly approved by the Registrar of concerned affiliating university.
- (iv) The institution has not submitted Form A towards maintenance of Endowment and Reserve Fund of Rs 12 Lakh as per NCTE Regulations, 2014.
- (v) The institution has not submitted BCC in prescribed format. The BCC submitted by the institution wherein the Total Built up area and Multipurpose Hall is not mentioned.
- (vi) Website details not provided by the institution.

Hence, the Committee decided to withdraw the recognition granted to S.K.B. College of Education, Pudur village, Kunnavalasm Poost, Tiruvallur – 631210, Tamil Nadu for conducting B.Ed course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of S.K.B. College of Education, Pudur village, Kunnavalasm Poost, Tiruvallur – 631210, Tamil Nadu run by S. K. B. Educational Trust, Kunnavalam Post Thiruvallur – 631201, Tamil Nadu for conducting B.Ed. programme of two-year duration with an annual intake of 100 students (2 units) w.e.f. the next academic session.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
