

WHEREAS, the institution namely, Sri Sowbackiya College of Education, S. No. 195/12, Andimadam (P.O) Andimadam Panchayat, Ariyalur (Distt) 621801, Tamil Nadu was granted recognition for offering B.Ed course vide SRC NCTE's order dated 07.07,2009 of one year duration with an intake of 100 students. AND, WHEREAS, on 12,01,2015, the institution submitted an affidavit affirming adherence to Regulations, 2014. A revised provisional recognition order was issued to the institution on 20.03.2015 for offering B.Ed course of two years duration with an intake of 100 students ( 2 units of 50 students each) subject to fulfillment of certain conditions mentioned therein.

AND WHEREAS, the matter was placed before in 388th meeting of SRC held on 14th - 15th September 2020 wherein the Committee decided to issue Show Cause Notice to the instituion. Accordingly, as per the decision of SRC, a SCN was issued on 23.09.2020.

AND WHEREAS, the institution vide letter dt. 22.01.2021 submitted compliance / documents in response to SCN.

AND WHEREAS, the matter was finally considered by the SRC in its 394th Virtual Meeting held from 27th - 28th January 2021 decided as under: -

"On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution Sri Education, Sowbackiya College of 195/12, Udayarpalayam, Ariyalur 621801, Tamil Nadu for B.Ed programme for 2 basic units of 50 students each unit."
