WHEREAS, the recognition was granted to the Adiparasakthi Teacher Training Institute, No. 165, Sri RajasakthiVinayakarKoil Street, V.P. Nagar, Muthialpet, Pondicherry-605008. Vide SRC (NCTE) F.TN/ELE/SRO/NCTE/2005-2006/4032 dt. 16.11.2005 for conducting D.T.Ed. course of two year duration with an annual intake of 100 students from the academic session 2005-2006.

- 2. AND WHEREAS, a show cause Notice under section 17of NCTE issued on Non-Maintenance of Norms and Standards by the teacher education Institutions recognized by SRC, NCTE on data10.09.2009 & 29.09.2009 to reply within 21 days. The institution did not submitted reply to Show Cause Notice.
- 3. AND WHEREAS the matter was further considered by the SRC in its 381st meeting held on 31st October-01st November 2019 and the Committee decided to issue Show Cause Notice. Accordingly, Show Cause Notice was issued on08.09.2020 to reply within 30 days. The institution did not submitted reply to Show Cause Notice.
- AND WHEREAS, the matter was further considered by the SRC in its 393rd meeting held on 05th -06th January 2021 and the Committee decided to issue Final Show Cause Notice. Accordingly, Final Show Cause Notice was issued on08.01.2021 to reply within 21 days. The institution has not submitted any compliance against Final Show Cause Notice.
- AND WHEREAS, the matter was further considered by the SRC in its 396th meeting held on 03rd March, 2021 and the Committee decided as follows:-
 - 1. The Committee noted that due to non-compliance of SCN dated 08.09.2020 for submission of requisite documents to verify infrastructure & instructional facilities a Final Show Cause Notice dated 08.01.2021 was issued to the institution. However the institution failed to submit the requisite documents as per Final Show Notice dated 08.01.2021.

Hence, the Committee decided to withdraw the recognition granted to Adiparasakthi Teacher Training Institute, RajasakthiVinayakarKoil Street, V.P. Nagar, Muthialpet, Pondicherry -605008 for conducting **D.T.Ed.** course with effect from the next academic

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to to Adiparasakthi Teacher Training Institute, No. 165, Sri Rajasakthi VinayakarKoil Street, V.P. Nagar, Muthialpet, Pondicherry-605008 for conducting D.T.Ed. course with effect from the the next academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.
- **7.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
