**WITHDRAWAL ORDER**

WHEREAS, the recognition was granted to the institution namely Sree Sai Siddhartha College of Education, K.V. Reddy Nagar, Opp S.L.V. Talkies, Tadipatri, Anantapur – 515411, Andhra Pradesh run by Sri Siddhartha Educational Society, Tadipatri, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/2006-2007/685 dt. 12.04.2007 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 21.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 13.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, on the basis of request, the SRC in its 342<sup>nd</sup> meeting decided for reduction of intake from 2 units to 1 unit. Accordingly, an order no. F.No. SRO/NCTE/APS07094 /B.Ed./AP/2017-18/94053 dated 21.07.2017 was issued to the institution reduction of intake 2 units to 1 unit.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice was issued to the institution on 09.04.2019. The institution has not submitted any reply to the Show Cause Notice. The SRC in its 381<sup>st</sup> Meeting, the Committee considered the matter and decided to issue Final Show Cause Notice to the institution to submit the compliance / reply to the conditions mentioned therein. Accordingly, a Final Show Cause Notice was issued to the institution on 15.11.2019. The institution has not submitted any reply in response to the Final Show Cause Notice.

AND WHEREAS, the matter was finally considered by the SRC in its 395<sup>th</sup> meeting held on 25<sup>th</sup>-26<sup>th</sup> February 2021 considered the matter and decided as under:-

*"The original files of the Institution along with other related documents, NCTE Act, 1993; Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -*

1. The Committee noted that institution has failed in submission of reply to the Final Show Cause Notice issued on 15.11.2019.

*Hence, the Committee decided to withdraw the recognition granted to Sree Sai Siddhartha College of Education, K.V. Reddy Nagar, Opp. S.L.V. Talkies, Tadipatri, Anantapur 515411, Andhra Pradesh for conducting B.Ed course with effect from the next academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."*

**NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **Sree Sai Siddhartha College of Education, K.V. Reddy Nagar, Opp. S.L.V. Talkies, Tadipatri, Anantapur 515411, Andhra Pradesh** run by **Sri Siddhartha Educational Society, Tadipatri, Andhra Pradesh** for conducting B.Ed. programme of two-year duration with an annual intake of 50 students (1 unit) w.e.f. the next academic session i.e., 2021-2022 onwards.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

*"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."*

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
