WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely Sree College of Education, H. No. 7-7-13-2, Nehru Nagar, Near Venkateswara Swamy Temple, Kurnool, Andhra Pradesh-518222 run by Muniswamy Technical & Rural Development Educational Society, Kurnool, Andhra Pradesh was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2007-2008/11595 dt. 19.09.2007 for conducting (Secondary) B.Ed. course of one year' duration with an annual intake of 100 students from the academic session 2007-2008.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 22.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 12.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students for two basic units from the academic session 2015-16 with a condition to maintain.

AND WHEREAS, the permission is hereby accorded by SRC vide order no. F.SRO/APSO7380/B.Ed./AP/2016/85742 dt. 30.05.2016 to the institution namely Sai Sree College of Education, H.no. 7-7-13-2, Nehru Nagar, Near VenkateswaraSwamyh Temple, Dhone, Kurnool, Andhra Pradesh -518222 to Shift its Premises to the new location/building at Sai Sree College of Education, Plot/Khasara No. 157/1, Venkatanyanipalli Village, Dhone Taluk and Post Office, Dhone Town, Kurnool District, Andhra Pradesh-518222.

AND WHEREAS, the matter was placed before in 314th meeting of SRC held on 27th & 28th May 2016 wherein a general decision was taken to cause inspection of such cases. Accordingly, as per the decision of SRC, a letter for inspection was sent on dt. 14.06.2016 and the inspection conducted on dt. 26.10.2016.

AND WHEREAS, the status of issuance of SCN/FSCN was considered by the Sub-Committee constituted by the SRC in its meeting held on 22nd October 2019. The Sub-Committee noted that institution has not submitted requisite documents or only part reply has been submitted. Accordingly, a First Show Cause Notice was issued to the institution vide dt. 04.11.2019. The institution vide letter dt. 16.11.2019 submitted reply of First Show Cause Notice.

AND WHEREAS, the matter was placed before the SRC in its 393rd Meeting held on 05th & 06th January 2021 considered and decided to issue Final Show Cause Notice to the institution. Accordingly, as per the decision a Final Show Cause Notice was issued to the institution vide dt. 11.01.2021. Thereafter, the institution did not submit the reply of Final Show Cause Notice.

AND WHEREAS, the matter was placed before the SRC in its 395th Meeting held on 25th & 26th February 2021 and considered the matter as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

MI

1. The Committee noted that due to non-compliance of SCN dated 04.11.2019 for submission of requisite documents to verify infrastructure & instructional facilities a Final Show Cause Notice dated 11.01.2021 was issued to the institution. However, the institution failed to submit the requisite documents as per Final Show Notice dated 11.01.2021.

Hence, the Committee decided to withdraw the recognition granted to Sai Sree College of Education, H.No.7-7-13-2, Nehru Nagar, Near Venkateswara Swamy Temple, Kurnool-518222, Andhra Pradesh for conducting B.Ed. course with effect from the next academic session i.e., 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Sai Sree College of Education, Plot/Khasara No. 157/1, Venkatanyanipalli Village, Dhone Taluk and Post Office, Dhone Town, Kurnool District, Andhra Pradesh-518222 run by Muniswamy Technical & Rural Development Educational Society, Kurnool, Andhra Pradesh for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units) for B.Ed. course with effect from the next academic session i.e. 2021-2022 onwards.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website www.ncte-india.org, with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
