WHEREAS, the recognition was granted to the institution namely, Siddhartha College of Physical Education, Khasara No. 44, Plot No. 134A, Street, Chinthagunta Village, C Gollapalli Post, Chandragiri Taluk, Tirupati, City, Chittoor District — 517505, Andhra Pradesh run by Siddhartha Educational Academy, 44, Plot No. 134A, Street, Chinthagunta Village, C Gollapalli Post, Chandragiri Taluk, Tirupati, City, Chittoor District — 517505, Andhra Pradesh vide order No. F.SRC/NCTE/SRCAPP2133/B.P.Ed./AP/2015/16/65161 dated 19.05.2015 for conducting B.P.Ed. programme of two-years duration with an annual intake of one basic unit of 100 (two sections of 50 students each) from the academic session 2015-16.

AND WHEREAS, the SRC in its 388<sup>th</sup> meeting held on 14<sup>th</sup> – 15<sup>th</sup> September, 2020 considered the matter and decided to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 22.02.2021. The institution has submitted reply a letter dated 09.03.2021 but with the request for extension of time to submit reply and no documents were submitted.

AND WHEREAS, the SRC in its 407<sup>th</sup> meeting held on 15<sup>th</sup> February, 2022 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice on 22.02.2021. The institution failed to submit reply alongwith the requisite documents/information to the Final Show Cause Notice (FSCN).

Hence, the Committee decided to withdraw the recognition granted to Siddhartha College of Physical Education, Khasara No. 44, Plot No. 134A, Street, Chinthagunta Village, C Gollapalli Post, Chandragiri Taluk, Tirupati, City, Chittoor District – 517505, Andhra Pradesh for conducting B.P.Ed. & D.P.Ed. programme with effect from the academic session i.e. 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Siddhartha College of Physical Education, Khasara No. 44, Plot No. 134A, Street, Chinthagunta Village, C Gollapalli Post, Chandragiri Taluk, Tirupati, City, Chittoor District – 517505, Andhra

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
