WHEREAS, the recognition u/s 14 of NCTE Act, 1993 was granted to the institution namely, Sri Sarada College of Education for Women, Sarada Nagar, Ariyakulam, Maharaja Nagar Post, Tirunelveli District, Tamilnadu-627011 vide order no. F.TN/SEC/SRO/NCTE/B.Ed./2005-2006/6794 dt. 13.07.2006 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2005-2006.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 20.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 13.05.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of **100 students** for **two basic units** from the academic session 2015-16.
- 3. **AND WHEREAS**, the SRC in its 388th meeting held on 14th 15th September, 2020 considered the matter and decided to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points. Accordingly, a Show Cause Notice was issued to the institution on 11.11.2021. The institution has submitted reply on 26.08.2019.
- **4. AND WHEREAS,** the SRC in its 405th meeting held on 13th 14th December, 2021 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 28.12.2021. The institution has submitted reply on 04.01.2022.
- 5. AND WHEREAS, the SRC in its 408th Meeting held on 02nd March, 2022 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide letter dated 04.01.2022. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution did not submit latest approval of faculty issued by the affiliating body. The institution also failed to submit supporting documents in terms of educational qualification of the faculty and experience certificate of the Principal.
- 2. The institute failed in submission of the bank statement of all individual faculty and institution's bank statement duly certified by the concerned bank showing

- disbursement of salary through bank Account to faculty as required under clause 10 (3) of NCTE Regulation, 2014.
- 3. The institution has submitted a Notarized copy of Building Plan not approved by the competent Authority. Hence, it is approved by Private Engineer.
- 4. The institution has submitted a photocopy of BCC in which Multi-purpose Hall area is not mentioned.

Hence, the Committee decided to withdraw the recognition granted to Sri Sarada College of Education for Women, Sarada Nagar, Ariyakulam, Maharaja Nagar Post, Tirunelveli Dist. – 627011, Tamilnadu for conducting B.Ed. programme with effect from the academic session i.e., 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Sri Sarada College of Education for Women, Sarada Nagar, Ariyakulam, Maharaja Nagar Post, Tirunelveli Dist. 627011, Tamilnadu run by Sri Ramakrishna Tapovanam, Sarada Nagar, Ariyakulam, Maharaja Nagar Post, Tirunelveli Dist.,s Tamilnadu— 627011 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (2 basic units) with effect from the academic session i.e., 2022-2023 onwards.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
