WITHDRAWAL ORDER

WHEREAS, the recognition u/s 14 of NCTE Act, 1993 was granted to the institution namely, **Sri Vedanarayana College of Education, 67/3,4,7, Erikambhatta Village, Narayanavanam Post & Mandal, Chittoor District – 517581, Andhra Pradesh** run by **Sri Vedanarayana Educational Society, Chittoor District, Andhra Pradesh** vide order no. F.SRC/NCTE/APS07198/B.Ed./2006-2007/5432 dt. 26.06.2007 for conducting B.Ed. course with an annual intake of 100 students from the academic session 2006-2007.

2. **AND WHEREAS**, after promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 18.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 14.05.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of **50 students for one basic unit** from the academic session 2015-16.

3. **AND WHEREAS**, the status of issuance of SCN/FSCN was considered by the Sub-Committee constituted by the SRC in its meeting held on 22nd October, 2019. The Sub-Committee noted that institutions have not submitted requisite documents or only part reply has been submitted. The Sub-Committee decided to issue First Show Cause Notice. Accordingly, as per the decision of SRC a First Show Cause Notice was issued to the institution on 24.10.2019. The institution has submitted reply on 19.11.2019.

4. **AND WHEREAS**, the SRC in its 389th meeting held on 12th – 14th October, 2020 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution dated 21.10.2020. The institution submitted reply on 28.10.2020.

5. **AND WHEREAS**, the SRC in its 395th meeting held on 25th – 26th February 2021 has considered the matter and decided to issue a last reminder letter. Accordingly, as per the decision of SRC, a last reminder letter was issued to the institution on 08.03.2021. The institution has submitted reply on 08.03.2021.

6. **AND WHEREAS**, the SRC in its 408th Meeting held on 02nd March, 2022 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Last Reminder Letter. The institution has submitted its reply on 08.03.2021. The Committee observed the reply submitted by the institution and found the following deficiencies.

1. The institution was issued a Last Reminder Letter dated 08.03.2021 with the direction to submit the latest approval of faculty issued by the University. The institution had submitted the approval of 16 faculty issued by the S.V. University vide letter dated 14.08.2015 and stated that there is no change in faculty since 2015. The institution failed to submit latest staff list duly approved by the affiliating body.
2. The institution was informed that the size of the M.P. Hall is less than 2000 sq.ft., now the institution submitted a building plan showing M.P. Hall as 2508 sq.ft. and mentioned that "the same to be represent on plan of building".
3. The institution failed in submission of the bank statement of all individual faculty and institution's bank statement duly certified by the concerned bank showing disbursement of salary through bank Account to faculty as required under clause 10 (3) of NCTE Regulation, 2014.

Hence, the Committee decided to **withdraw the recognition** granted to **Sri Vedanarayana College of Education, 67/3,4,7, Erikambhatta Village, Narayanavanam Post & Mandal, Chittoor District – 517581, Andhra Pradesh** for conducting **B.Ed. programme** with effect from the academic session i.e., 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

7. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition grant to **Sri Vedanarayana College of Education, 67/3,4,7, Erikambhatta Village, Narayanavanam Post & Mandal, Chittoor District – 517581, Andhra Pradesh** run by **Sri Vedanarayana Educational Society, Chittoor District, Andhra Pradesh -517581** for conducting **B.Ed. programme** of two years duration with an annual intake of 50 students (1 basic unit) with effect from the academic session i.e., 2022-2023 onwards.

8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
