WHEREAS, the recognition u/s 14 of NCTE Act, 1993 was granted to the institution namely, Sree Konaseema Bhanoji Ramars College, East Godavari District, Andhra Pradesh vide order no. F.AP/NEW/B.ED./218/SRO/NCTE/2002-2003/6150 dt. 26.03.2003 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2002-2003.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has 2. submitted affidavit dated 02.02.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 12.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students for two basic units from the academic session 2015-16.
- AND WHEREAS, the SRC in its 363rd meeting held on 17th to 19th September 2018 considered the matter and decided to issue Show Cause Notice. Accordingly, as per decision of SRC a Show Cause Notice was issued to the institution on 17.10.2018. The institution did not submit reply to the Show Cause Notice.
- AND WHEREAS, the SRC in its 393rd meeting held on 5th 6th January 2021 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 08.01.2021. The institution has submitted reply on 25.01.2021.
- AND WHEREAS, the SRC in its 395th meeting held on 25th 26th February, 2021 has considered the matter and decided to issue last reminder letter. Accordingly, as per the decision of SRC, a last reminder letter was issued to the institution on 15.03.2021. The institution has submitted reply on 19.01.2022.
- AND WHEREAS, the SRC in its 408th Meeting held on 02nd March, 2022 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations

The institution was issued a Last Reminder Letter. The institution has submitted its reply vide dated 19.01.2022. The Committee observed the reply submitted by the institution and found the following deficiencies.

1. The institution was issued a Last Reminder Letter dated 15.03.2021 with the direction to submit the latest staff list in the prescribed format duly approved by the affiliating body. The institution had submitted a Proforma of 10 faculty

signed by the Dean and Registrar of A.N. University, A.P. but the signature of Registrar is not legible. The institution also failed to submit supporting documents in terms of educational qualification of the faculty and experience certificate of the principal.

2. The institute is also failed to submit the bank statement showing disbursement of salary through bank Account to faculty as required under clause 10 (3) of

NCTE Regulation, 2014.

Hence, the Committee decided to withdraw the recognition granted to Sree Konaseema Bhanoji Ramars College, East Godavari District, Andhra Pradesh for conducting B.Ed. programme with effect from the academic session i.e., 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Sree Konaseema Bhanoji Ramars College, East Godavari District, Andhra Pradesh for conducting B.Ed. Brogramme of two years duration with an annual intake of 100 students (2 basic units) with effect from the academic session i.e., 2022-2023 onwards.
- 8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
