WHEREAS, the recognition u/s14 Act of NCTE, 1993 was granted to the institution namely. Ruben College of Education, 4-70D, Thadikarankonam junction, Kanyakumari District-629851, TamilNadu vide order no.F.TN/SEC/SRO/NCTE/2005-2006/1591 dt.07.07.2005 for conducting Secondary B.Ed. Course of one year duration with an annual intake of 100 students from the academic session 2005-06.

- AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution has 2. consented to come under new Regulations vide a notarized affidavit dated 22.01.2015. A revised provisional recognition order was issued on 18.03.2015 to the institution for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.
- AND WHEREAS, the SRC in its 388th meeting held on 14th 15th September. 2020 considered the matter and decided to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 21.09.2020. The institution has submitted reply on 07.12.2020.
- AND WHEREAS, the SRC in its 401st meeting held on 11th 12th August 2021 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, a Final Show Cause Notice was issued to the institution on 31.08.2021. The institution has not submitted reply to the Final Show Cause Notice.
- AND WHEREAS, the SRC in its 408th Meeting held on 02nd March 2022 considered the matter and the institution failed to submit a reply to Final Show Cause Notice and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993. Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN) the institution failed in submission of its reply with all relevant documents asked under Final Show Cause Notice dated 31.08.2021 till date.

Hence, the Committee decided to withdraw the recognition granted to Ruben College of Education, 4-70D, Thadikarankonam Junction, Kanyakumari District-629851, Tamilnadu for conducting B.Ed. & M.Ed. programme with effect from the academic session i.e. 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above".

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Ruben College of Education, 4-70D, Thadikarankonam Junction, Kanyakumari District-629851, Tamilnadu run by Ruben Educational & Charitable Trust, 4-70D, Thadikarankonam Junction, Kanyakumari District-629851, Tamilnadu for conducting B.Ed. Programme of two years duration with an annual intake of 100 students (2 basic units) with effect from the academic session i.e., 2022-2023 onwards.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
