WHEREAS, the recognition u/s 14 of NCTE Act, 1993 was granted to the institution namely, Matha College of Teacher Education Annavasal Road, Vaampuram, Manamadurai Sivagangai District, Tamilnadu-630606 run by Matha Memorial Education Trust, Annavasal Road, Vaampuram, Manamadurai, Sivagangai District, Tamilnadu-630606 vide order no. F.TN/B.Ed./SEC/SRO/NCTE/2006-2007/7216 dt. 11.08.2006 for conducting Secondary (B.Ed.) course of one year duration from the academic session 2005-06 with an annual intake of 100 students.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 18.05.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 29.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 369<sup>th</sup> Meeting held on 28.01.2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted requisite documents/VT report accompanied with requisite documents in responds to RPRO issued by the SRC. Accordingly, as per decision of SRC a Show Cause Notice was issued to the institution on 20.06.2019. The institution has submitted reply on 16.08.2019.
- 4. AND WHEREAS, the SRC in its 405<sup>th</sup> Meeting held on 13<sup>th</sup> & 14<sup>th</sup> December, 2021 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 28.12.2021. The institution has submitted reply on 28.12.2021.
- 5. AND WHEREAS, the SRC in its 408<sup>th</sup> Meeting held on 02<sup>nd</sup> March, 2022 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 28.12.2021. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. Vide Final Show Cause Notice dt. 28.12.2021 the institute was directed to submit latest approval of sufficient faculty, but the institute failed in submission. The institution also failed to submit supporting documents in terms of educational qualification of the faculty and experience certificate of the Principal.
- 2. The institute failed in submission of satisfactory reply towards the deficiency of less size of multipurpose hall.
- 3. The institute had failed in submission of bank statement of faculty showing disbursement of salary through bank account as required under clause 10(2) of NCTE Regulations, 2014 and directed to submit vide Final Show Cause Notice.
- 4. The institute failed in submission of details of administrative and professional staff
  Required under clause 5.3 of appendix 4 of NCTE Regulations, 2014 and directed to submit in Final Show Cause Notice.
- 5. The website is still not complete as per clauses 7 (14) (i), 8 (14) and 10(3) of NCTE Regulations, 2014.

Hence, the Committee decided to withdraw the recognition granted to Matha College of Teacher Education, Annavasal Road, Vaampuram, Manamaduarai, Sivagangai District, Tamilnadu-630606 for conducting B.Ed. & D.T.Ed. programme with effect from the academic session i.e., 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Matha Teacher Training Institute, Annavasal Road, Vaanpuram, Manamadurai, Siagangai District, Tamilandu-630606 run by Matha Memorial Education Trust, Annavasal Road, Vaanpuram, Manamadurai, Siagangai District, Tamilandu-630606 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (2 basic units) with effect from the academic session i.e., 2022-2023 onwards.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under subsection (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
