WHEREAS, the recognition u/s14 Act of NCTE, 1993 was granted to the institution namely, College of Education, Thimmapuram Village, Madhuravada Post, Visakhapatnam, Andhra Pradesh-531163 vide order no. F.SRO/NCTE/B.Ed./2007-2008/11852 dt.25.09.2007 for conducting B.Ed. Course of one year duration with an annual intake of 100 students.

- AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution has consented to come under new Regulations vide a notarized affidavit dated 12.02.2015. A revised provisional recognition order was issued on 16.05.2015 to the institution for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.
- AND WHEREAS, the SRC in its 363rd Meeting held on 17th to 19th September, 2018 considered the matter and decided to issue Show Cause Notice. Accordingly, as per decision of SRC a Show Cause Notice was issued to the institution on 12.10.2018. The institution has submitted a written representation on 20.11.2018.
- AND WHEREAS, the SRC in its 381st Meeting held on 31st October & 01st November, 2019 the matter was considered and decided to issue Final Show Cause Notice to the institution. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 21.11.2019. The institution did not submit reply to the Final Show Cause Notice.
- AND WHEREAS, the SRC in its 397th Meeting held on 25th & 26th March 2021 considered the matter and decided to issue last reminder letter. Accordingly, as per decision of SRC a last reminder letter was issued to the institution on 07.04.2021. The institution has submitted reply on 12.05.2021.
- AND WHEREAS, the SRC in its 408th Meeting held on 02nd March 2022 considered the reply to Final Show Cause Notice and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Last Reminder Letter. The institution has submitted its reply on 12.05.2021. The Committee observed the reply submitted by the institution and found the following deficiencies.

1. The institute submitted a proforma of 16 faculty signed by the Registrar, Andhra University but the date of Joining is not mentioned. Further, the date of

joining of faculty is also not mentioned.

2. The institute failed in submission of the bank statement of all individual faculty duly certified by the concerned bank and institution's bank statement showing disbursement of salary through bank Account to faculty as required under clause 10 (3) of NCTE Regulation, 2014.

3. The institute submitted a copy of building plan but the same is not approval by

the competent authority.

4. As per building plan the size of multipurpose hall is only 108 sq. mt. (1162.50 sq. ft.) which is less than the requirement laid down under NCTE Regulations, 2014.

5. The institute was directed to submit certified/notarized copies of land

documents, NEC and LUC but only self-attested copies submitted.

6. Form 'A' issued by the concerned bank for FDRs of Endowment and Reserve Funds has not been submitted.

7. Website of the institute is not functional.

Hence, the Committee decided to withdraw the recognition granted to Prema Madhuravada Village, Thimmapuram College of Education, Visakhapatnam, Andhra Pradesh-531163 for conducting B.Ed. programme with effect from the academic session i.e. 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above".

- NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Prema College of Education, Thimmapuram Village, Madhuravada Post, Visakhapatnam, Andhra Pradesh-531163 run by Free Polio Surgical and Research Foundation, Visakhapatnam, Andhra Pradesh for conducting B.Ed. Programme of two years duration with an annual intake of 100 students (2 basic units) with effect from the academic session i.e., 2022-2023 onwards.
- Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
