WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely, **V.V.S. College of Education, U.Kothapalli, U.Kothapalli Mandalam, East Gadavari-533447, Andhra Pradesh** vide order no. F.SRO/NCTE/B.Ed./2007-2008/11471 dt. 17.09.2007 for conducting Secondary **B.Ed.** course of one-year duration with an annual intake of 100 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 21.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 06.05.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of **100 students** for **two basic units** from the academic session 2015-16.

3. **AND WHEREAS**, a Corrigendum was issued to the institution vide order no. F.SRO/NCTE/APS07667/B.Ed./AP/2015/77340 dated 31.10.2015 with an annual intake of 50 students for one basic unit.

4. **AND WHEREAS**, the institution has submitted a request dated 28.10.2021 regarding closure of the B.Ed. programme.

5. **AND WHEREAS**, the SRC in its 408th Meeting held on 02nd March, 2022 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

*The Committee agreed to close down the institution as requested by the society vide letter dated 28.10.2021 by withdrawing the recognition granted to **V.V.S. College of Education, U.Kothapalli Mandalam, East Godavari – 533447, Andhra Pradesh** for conducting **B.Ed. Programme** under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.*

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in this meeting."

6. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **V.V.S. College of Education, U.Kothapalli Mandalam, East Godavari – 533447, Andhra Pradesh** for conducting **B.Ed. programme** of two years duration with an annual intake of **50 students (1 basic unit)** with effect from the academic session i.e., 2022-2023 onwards.
