WHEREAS, the recognition was granted to the institution namely Aradhana College of Education, Rangareddy District, Andhra Pradesh vide SRC (NCTE) order no. F.AP/NEW/B.EdD/227/SRO/NCTE/2002-2003/6095 dt. 28.02.2003 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, the SRC in its 178th meeting held on 13-14th July 2009 considered the matter and decided to issue show cause notice of the institution has not shifted to permanent premises as per norms and standards and conditions mentioned in recognition order dated 28.02.2003/ not communicated the shifting of premises to the SRC and not paid the prescribed fees for shifting of premises.

AND WHEREAS, a show cause notice was issued to the institution on 27.08.2009. Reply was not received. On 31.12.2014, letters were issued to all existing institutions regarding notification of new Regulations 2014 seeking consent on their willingness for fulfilling the revised norms and standards before 31.10.2015.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution submitted affidavit dt.24.08.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 27.08.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

AND WHEREAS, the institution submitted its written representation on 20.06.2016 along with relevant documents, staff list and shifting fee of Rs. 1, 50,000/- DD dated 13.05.2016. The SRC in its 316th meeting held on 07th-08th July, 2016 considered the shifting proposal and the committee decided Cause inspection for shifting of B.Ed (2 units), Ask VT to collect all relevant documents; and, check esp. adequacy of built up area for B.Ed (2 units). The inspection of the institution was fixed, and intimation letter was issued to the institution on 18.07.2016. Accordingly, the inspection of the institution was conducted on 19.08.2016. The VT report received on 22.08.2016.

AND WHEREAS, the SRC in its 321st meeting held on 28th to 30th September, 2016 considered the VT report and decided to issue show cause notice as per the decision of SRC, a show cause notice was issued to the institution on 22.10.2016.

AND WHEREAS, the SRC in its 365th meeting held on 31st October to 1st November, 2018 considered the non-submission of SCN reply and decided to issue SCN. As per the decision of

SRC, a show cause notice was issued to the institution on 27.11.2018. The institution did not reply to the show cause notice till date.

AND WHEREAS, the Sub-Committee of the SRC in 380th meeting decided to issue Final Show Cause Notice to all such institution where reply to SCN has not been submitted by the institution. Accordingly as per the decision of SRC a Final Show Cause Notice was issued to the institution on 09.10.2019. The institution vide letter dated 05.12.2019 submitted its reply to the final show cause

AND WHEREAS, the SRC in its 384th meeting held on 12th -13th February, 2020 considered the matter and the committee decided to issue last reminder letter. Accordingly, as per the decision of SRC a last reminder letter was issued to the institution on 26.02.2020. The institution vide letter dated 26.02.2020 submitted its reply to the last reminder letter.

AND WHEREAS, the SRC in its 388th Meeting held on 14th & 15th September, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Last ReminderLetter dated 26.02.2020. The Committee carefully considered the reply submitted by the institution on 26.02.2020 and found the following deficiencies: -

- 1. The institution has not shifted its institution to own permanent building which is a violation of the NCTE Regulations 2002, 3(c).
- 2. Five faculty Members (Assistant Professor) has been shown appointed after promulgation of NCTE Regulations, 2017, and they do not possess NET/Ph.Dqualification as per provisions of the NCTE Regulations, 2017.
- 3. The institution has submitted notarized copy of building plan but multipurpose hall has not mentioned.

Hence, the Committee decided to withdraw the recognition granted to Aradhana College of Education, Chevella Revenue Division # 11-34/1, Opp Sub Station Chevella, Rangareddy District-501503, Telanganafor conducting B.Edcoursesw.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Aradhana College of Education, Chevella Revenue Division # 11-34/1, Opp Sub Station Chevella, Rangareddy District-501503, Telangana for conducting B.Ed. programme of two year duration with an annual intake of 100 students (2 units) from the next academic session starts after issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
