AND WHEREAS, the recognition was granted to the institution namely, Christ Nagar College of Education, Chavarapuram, Thiruvallom, Thiruvanananthapuram-695027, Kerala run by Christ Nagar College of Education Charitable Society, Kaudiar P.O. Thiruvanananthapuram-695003, Kerala vide SRC (NCTE) order No. F.KL/SEC/N/152/SRO/NCTE/2004-2005/913 dated 25.02.2005 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted an affidavit dated 20.01.2015 for its willingness for adherence of provisions of new Regulations.
- 3. AND WHEREAS, a Revised Provisional Recognition Order was issued to the institution on 15.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-2016.
- 4. AND WHEREAS, the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC, a show cause notice was issued to the institution on 17.06.2019. In response, the institution has not submitted any compliance.
- 5. AND WHEREAS, the matter was further considered by the Sub-Committee constituted by the SRC as per its decision taken 380th meeting held from 18-19 September 2019. The Sub- Committee of the SRC decided to issue Final Show Cause Notice to all such institution where reply to SCN has not been submitted by the Institution. Accordingly, a Final Show Cause Notice was issued to the institution on 10.10.2019. In response, the institution vide letter dated 18.11.2019 submitted reply to the Final Show Cause Notice.
- 6. AND WHEREAS, the matter was further considered by the SRC in its 388th meeting held on September 14-15, 2020 and the Committee decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution on 18.11.2019. The Committee observed and found the following deficiencies: -

1. The institution has not submitted certified copy of registered land documents.

2. The institution has not submitted Land Use Certificate duly approved by the

3. The institution has not submitted translated English version of Latest

4. The institution has submitted a photocopy of Building plan in that total built-up area requires 1500 sqm whereas it is mentioned as 936sqm. However, a notarized copy of Building plan not submitted. Site Area is not mentioned.

- 5. The institution has submitted an Original Staff list not approved by the Registrar consisting of one principal & Nine Assistant Professor and two part time lecturers submitted vide dated nil. Some deficiencies are:
  - a. Percentage of marks in r/o Principal is less than 55%.

b. Date of joining not mentioned in staff list.

- 6. The institution has not submitted an affidavit clearly stating status about land & building and Management (Society/Trust) at the time of recognition.
- 7. There is a variation in Land Document at the time of Recognition and now

Hence, the Committee decided to withdraw the recognition granted to Christ Thiruvanananthapuram-695027, Kerala for conducting B,Ed, course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds

- NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Christ Nagar College of Education, Chavarapuram, Thiruvaliom, Thiruvanananthapuram-695027, Kerala for conducting B.Ed. course of two years duration with an annual intake of
- Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government,"

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order.
