AND WHEREAS, the recognition was granted to the institution namely, Bafakhy Yatheemkhana B.Ed. Training College, Kalpakancherry, Via Tirur, Malappuram District, Pin - 676551, Kerala run by Valanannur Bafaky Yatheemkhana, Kalpakancherry P.O., Via Tirur, Malappuram District, Pin - 676551, Kerala vide SRC (NCTE) order No. F.KL/SEC/N/139/SRO/NCTE/2004-2005/752 dated 23.02.2005 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted an affidavit dated 27.01.2015 for its willingness for adherence of provisions of new Regulations.
- AND WHEREAS, a Revised Provisional Recognition Order was issued to the institution on 15.05,2015 for conducting B.Ed. course of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-2016.
- AND WHEREAS, the matter was placed before the SRC in its 322nd meeting held on 20-21 October 2016 and the committee decided to issue Show Cause Notice on the following points:
 - i. No documents have been received.
 - Send a notice, listing the documents required for reply within a month. ii.
- AND WHEREAS, as per decision taken in the meeting 322nd, a Show Cause Notice was issued to the institution on 01.12.2016. In response, the institution has submitted a letter in response to the Show Cause Notice vide letter dated 23.12.2016.
- AND WHEREAS, the matter was placed before the SRC in its 351st meeting held on 28-29 December 2017 and the committee decided to SRC Meeting Agenda giving preference to consideration of new/pipeline cases likely to get FR w.e.f. 2018-19.
- AND WHEREAS, SRC in its 382nd meeting held on 26-27 November 2019 and the 7. committee decided to issue of Final Show Cause Notice. Accordingly, a final show cause Notice was issued to the institution on 10.12.2019. In response, the institution has submitted a letter in response to the Final Show Cause Notice vide letter dated 26.12.2019.
- AND WHEREAS, the matter was further considered by the SRC in its 388th meeting 8. held on September 14-15, 2020 and the Committee decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act. 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution on 26.12.2019. The Committee observed and found the following deficiencies: -

- 1. The institution has submitted a notarized copy of land documents but certified copy issued by the competent authority has not been submitted.
- 2. The institution has submitted a computerized copy of NEC. However, a notarized copy of the same has not submitted.
- 3. The institution has not mentioned site area in building plan document.
- 4. The institution has not submitted Site Plan.
- 5. The institution has not mentioned multi-purpose hall area in BCC.
- 6. The institution has submitted site plan but not as per NCTE Regulation.
- 7. The Institution has submitted BCC for B.Ed. plus M.Ed. in totalling 1555. 93sq.m built-up area against the requirement 2000 sq.mt. as per NCTE Regulation 2014 and a Multipurpose hall area is not mentioned in the
- 8. The institution has submitted an Original Staff list approved by the Registrar, University of Calicut consisting of one principal, Seven Assistant Professor and two part time teaching staff submitted for one unit vide dated Nil. Some deficiencies in staff list are: - "Ganisha T.V" working as an Assistant Lecturer in Mathematics, Original PG Certificate not verified. Four Lecturers does not have NET/Ph.D. as per NCTE (Recognition Norms & Procedure) (Amendment) Regulations, 2017 dated 29,05.2017 (amended
 - vide notification on 09.06.2017) The details are as follows: -"Salih E A" (Asst. Professor in Physical Science)
 - "Famitha S" (Asst. Professor in Education)
 - "Ganisha T.V" (Asst. Professor in Mathematics)
 - "Sahira P" (Asst. Professor in IT)
- 9. The institution has submitted copy of Matured FDRs.

Hence, the Committee decided to withdraw the recognition granted to BafakhyYatheemkhana B.Ed. Training College, Kalpakancherry, Via Tirur, Malappuram District, Pin - 676551, Kerala for conducting B.Ed. course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to BafakhyYatheemkhana B.Ed. Training College, Kalpakancherry, Via Tirur, Malappuram District, Pin - 676551, Kerala for conducting B.Ed. course of two years duration with an annual intake of 50 students w.e.f. the next academic session.

10. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

11. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
