WHEREAS, the recognition was granted to the institution namely Shams-UI-UIoom College of Education, Podili, Grampanhayat, Podili Mandal, Prakasam District, Andhra Pradesh. run by Islamic Education and Cultural Society, H.No. Markapur Prakasam District, Andhra Pradesh vide SRC (NCTE) order no. F.AP/B.Ed/NEW/SRO/NCTE/2004-2005 dt. 29.05.2005 for conducting B.Ed. course of one-year duration with an annual intake of 100 students of one-year duration from the academic session 2004-2005.

- 2. AND WHEREAS, inspection of the institution under section 17 was conducted on 23.12.2008. The VTR was placed before SRC in its 170^{th} meeting held on $16^{th}-17^{th}$ February 2009 the SRC in its 171^{st} meeting held on $16^{th}-17^{th}$ March 2009 and SRC decided to issue Notice. As per the decision of SRC notice was issued to the institution on 04.04.2009. The institution has submitted its written representation on 24.04.2009 enclosing approved building completion certificate, affidavit and staff profile.
- 3. **AND WHEREAS**, the SRC in its 177th meeting held on 22nd 23rd June, 2009 considered the and decided to issue to withdraw. Accordingly, as per the of SRC withdrawal order No. F.SRO/NCTE/APS03291/2009-10/14520 dated 13.07.2009 was issued to the institution.
- 4. **AND WHEREAS,** aggrieved by the withdrawal order of SRC, the institution preferred an appeal to NCTE-Hqrs. NCTE, Hqrs. vide order. F.No. 89-879/2009-Appeal dated 08.10.2009 the Council hereby remands back the case.
- 5. **AND WHEREAS**, the SRC in its 281st meeting held on 19th February, 2015 considered the matter, other relevant documents of the institution decided to constitute VT. The inspection of the institution was conducted on 28.03.2015 and the VT Report was received by this office on 01.04.2015. The SRC in its 285th meeting held on 17th April, 2015 considered the matter VT report dated 28.03.2015 decided to permit shifting
- 6. AND WHEREAS, the SRC issued permitting shifting vide order no. F.SRO/NCTE /APSO3291/AP/2015/64447 dt. 12.05.2015 to the institution for shifting of premises to new location at Sy. No. 948/3, Podili, Gram Panchayat, Podili, Ongabe Road, Podili Village & Mandal, Prakasam District-523240, Andhra Pradesh.

- 7. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 19.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 12.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 150 (Three basic units) from the academic session 2015-16.
- 8. **AND WHEREAS**, the SRC issued a Corrigendum order no. F.SRO/NCTE/APS03291 /B.Ed/AP/2015/69914 dated 16.07.2015 to the institution intake of 2 units.
- 9. AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 30.04.2019. The institution vide letter dated 27.12.2019 submitted reply to the alongwith land & building documents having address as Sy.No. 948/3, Ongole Road Podili, Panchayat, Prakasam District-523240 Andhra Pradesh and staff list etc.
- 10. AND WHEREAS, the SRC in its 388th meeting held on 14th & 15th September, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution vide letter dt. 27.12.2019, the Committee decided that the continuation order be issued to the Institution Shams-Ul-Uloom College of Education, Prakasam District- 523240, Andhra Pradesh for B.Ed programme for 2 basic units (50 students each unit)

- 11. NOW THEREFORE, this order is issued permitting the institution i.e. Shams-UI-UIoom College of Education, Sy.No. 948/3, Ongole Road Podili, Panchayat, Prakasam District-523240 Andhra Pradesh run by Islamic Education and Cultural Society, Prakasam District-523240, Andhra Pradesh for continuation of recognition for B.Ed course of two years duration with an intake of 100 students (2 basic units) of subject to fulfillment of the following conditions:-
 - I.The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II.The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

- IV The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 12. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 13. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake, available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 15. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 16. The institution shall make available the list of students admitted on its official website.
- 17. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
