WHEREAS, the recognition was granted to the institution namely Sri Chaitanya College of Education, P.No. 481/2 & 496/4A, Panukuvalsa Village, Salur Post, Vizianagaram District-535591, Andhra Pradesh run by Sri Vinayaka Educational Society, Vizianagaram District, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/APS07179/B.Ed/2007-2008/15764 dt. 07.12.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is 2. submitted affidavit dated 25.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 19.03.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- AND WHEREAS, on the basis of request, the SRC in its 342nd meeting decided for reduction of intake from 2 units to 1 unit. Accordingly a vide order F.No.SRO/NCTE/APSO7179 /B.Ed/AP/2017-18/94084 dated 21.07.2017 was issued to the institution 2 units to 1 unit.
- AND WHEREAS, the SRC in 381th meeting held on 31st Oct & 1st Nov, 2019 decided to 4. issue Show Cause Notice to all such institution where compliance/representation has not been submitted by the institution. Accordingly, as per the decision of SRC a Final show cause notice was issued to the institution on 08.11.2019. The institutions vide letter dated nil received on 10.09.2020 submitted reply to the alongwith land & building documents having address as S.No. 418/2, 496/4A Panukuvalasa Village, Pachipenta Mandal Vizianagaram Dist. Andhra Pradesh and staff list etc.
- AND WHEREAS, the SRC in its 388th meeting held on 14th & 15th September, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

NOW THEREFORE, this order is issued permitting the institution i.e. Sri Sri Chaitanya College of Education, P.No. 481/2 & 496/4A, Panukuvalsa Village, Salur Post, Vizianagaram District-535591, Andhra Pradesh run by Sri Vinayaka Educational Society, Vizianagaram District, Andhra Pradesh for continuation of recognition for B.Ed course of two years duration with an intake of 100 students (2 units) of subject to fulfillment of the following conditions:-
 - 1. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II.The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time:
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 7. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 8. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 9. - j. The institution shall be free to post additional relevant information, if it so desires.

- 10. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
