WHEREAS, the recognition was granted to the institution namely Siddartha College of Education, Pentakota Road, S.Annavaram, Tuni, East Godavari – 533401, Andhra Pradesh run by Dr. K.Leela Devy Educational Society, East Godavari, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/2006-2007/3210 dt 23.05.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

**AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 19.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 12.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

AND WHEREAS, the institution submitted written representation on 09.07.2015 requesting for reduction of strength from 2 units to 1 unit in its B.Ed. course. The SRC issued a Corrigendum vide Order No.F.SRO/NCTE /APS07483/B.Ed/AP/201569872 dated 15.07.2015 to the institution reduce intake of 2 units to 1 unit.

AND WHEREAS, as per the decision 369<sup>th</sup> Meeting of SRC held on 28.01.2019 a Show Cause Notice to be issue to all such institution which have not submitted compliance. Accordingly, a show cause notice was issued to the institution on 05.02.2019. The institution vide letter dated 26.02.2019 submitted its reply to the show cause notice.

AND WHEREAS, the SRC in 381<sup>th</sup> meeting held on 31<sup>st</sup> Oct & 1<sup>st</sup> Nov, 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT Repost accompanied with requisite documents. As per the decision of SRC a final show cause notice was issued to the institution on 20.11.2019. The institution did not submitted reply to the final show cause notice till date.

**AND WHEREAS**, the SRC in its 388<sup>th</sup> Meeting held on 14<sup>th</sup> & 15<sup>th</sup> September, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN) dated 20.11.2019.

 The institution has failed in submission of written representation along with all required documents in response to Final Show Cause Notice.

Hence, the Committee decided to withdraw the recognition granted to Siddartha College of Education, Pentakota Road, S.Annavaram, Tuni, East Godavari – 533401, Andhra Pradeshfor conducting B.Edcoursesw.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Siddartha College of Education, Pentakota Road, S.Annavaram, Tuni, East Godavari — 533401, Andhra Pradesh run by Dr. K. Leela Devy Educational Society, East Godavari, Andhra Pradesh for conducting B.Ed. programme of two year duration with an annual intake of 50 students (1 unit) w.e.f. the next academic session.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
