WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely **Prabhath College of Education, No. 21/451 B, B1,B2 Bye-Pass Road, Nandyal, Kurnool district-518501, Andhra Pradesh** run by **Prabhath Educational Society, Kurnool District, Andhra Pradesh** vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/2008-09/3934 dt 19.08.2008 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 13.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 27.04.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

AND WHEREAS, on the basis of request, the SRC in its 342nd meeting decided for reduction of intake from 2 units to 1 unit.

AND WHEREAS, as per the decision 369th Meeting of SRC held on 28.01.2019 a Show Cause Notice to be issue to all such institution which have not submitted compliance. Accordingly, a show cause notice was issued to the institution on 15.03.2019. The institution vide dated 05.12.2019 submitted its reply to the show cause notice.

AND WHEREAS, the SRC in 383rd meeting held on 07th to 09th January, 2020 considered the matter and decided to issue Final Show Cause Notice. Accordingly, a Final SCN was issued to the institution on 16.01.2020 the institution submitted its reply to the Final SCN along with documents on 20.01.2020.

AND WHEREAS, the SRC in its 388th Meeting held on 14th & 15th September, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee noticed that the institutions which were granted recognition on Rented Premises with a condition to shift its building to new permanent building. And, the institutions which have not yet shifted to its own permanent building.

1. The institution has not shifted its institution to own permanent building which is a violation of the NCTE Regulations 2002, 3(c).

In view of the above, the institution also not replied to remove the following deficiencies:

2. The institution has also not submitted an application for shifting of premise from rented to owned as required under NCTE Regulations.
3. The institution submitted sale deed survey No. 269/1, 269/3, 270 and at the time of recognition institution submitted lease deed period of three years 19.10.2006-18.10.2009 survey No 864 which is different survey No.
4. The institution has submitted photocopy of land document but certified copy not submitted.
5. The institution has submitted English version Non-Encumbrance Certificate but name and Period of search not mentioned.
6. The institution has submitted photocopy of site plan but not legible.
7. The institution has submitted photocopy of Building Completion Certificate but multipurpose hall not mentioned.
8. The institution has submitted photocopy of Staff list vide dated 28.10.2014 approved by the DEAN CDC College Development Rayalaseema University consisting of one principal & Sixteen Lecturer submitted.
9. The institution has principal appointed list but not approved by approved by the Affiliating body.
10. The institution has submitted photocopy of staff list 1+6 against the requirement 1+15 for B.Ed 2 units.

Hence, the Committee decided to **Withdraw the recognition** granted to **Prabhath College of Education, No. 21/451 B, B1,B2 Bye-Pass Road, Nandyal, Kurnool district-518501, Andhra Pradesh** for conducting B.Ed.course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **Prabhath College of Education, No. 21/451 B, B1,B2 Bye-Pass Road, Nandyal, Kurnool district-518501, Andhra Pradesh** run by **Prabhath Educational Society, Kurnool District, Andhra Pradesh** for conducting B.Ed. programme of two year duration with an annual intake of 50 students (1 unit) w.e.f. the next academic session.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such

course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
