WHEREAS, the recognition was granted to the institution namely Lakshmi Nagi Reddy College of Diploma in Elementary Education, Plot/Khasra No. 181/A, Rama Temple Street, Shanthi Nagar Road, Waddepally City and Post, Alampur Taluk, Mahbubnagar District-509144, Andhra Pradesh run by Motati Nagi Reddy Memorial Educational Society, Plot No. 1/4/3, Bheem Nagar, Gadwal Village and Post, Gadwal City and Taluk, Mahbubnagar District-509125, Andhra Pradesh vide SRC (NCTE) order No. F.NO.SRCAPP1598/D.EI.Ed/AP/2012/45880 dated 05.09.2012 for conducting D.Ed. course of two-year duration with an annual intake of 50 students.

AND WHEREAS, a letter is received from the Director of School Education Government of Telangana Hyderabad Lr.No.16/N1-3/2014 dated 06.05.2015. The replies of all the 22 colleges were placed before SRC in its 293rd meeting held on 29th-31st October 2015 and the committee decided to issue a letter the Director SCERT. As per the decision of SRC, the replies of the institutions are sent to the Director, SCERT on 02.11.2015. The institution vide letter dated 18.07.2020 submitted its written representation.

AND WHEREAS, the SRC in its 388th meeting held during 14th – 15th September, 2020 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee decided to withdraw the recognition granted to Lakshmi Nagi Reddy College of Diploma in Elementary Education, Plot/Khasra No. 181/A, Rama Temple Street, Shanthi Nagar Road, Waddepally City and Post, Alampur Taluk, Mahbubnagar District-509144, Telanganafor conducting D.El.Ed course under clause 17(1) of NCTE Act, 1993 on its own request made vide letter dated 18.07.2020. However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

(a) NOC from the affiliating body.

(b) NOC from the staff/faculty.

(c) Resolution of the management to the effect for closure of the course

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Lakshmi Nagi Reddy College

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
