WHEREAS, the recognition was granted to the institution namely, Nadar Saraswathi College of Teacher Education, Post Box No.55, Vadapudupatti, Annanji P.O., Theni-625531, TamilNadu run by Theni Melapettai Hindu Nadar Uravinmurai Trust, No.1100, Periyakulam Road, Theni District-625531, TamilNadu was granted recognition vide SRC (NCTE) order no.F.SRO/NCTE/M.Ed./2008/5125 dt. 22.09.2008 for conducting M.Ed. course of one year duration with an annual intake of 25 students. The enhancement of intake of 10 seats from existing 25 to 35 is permitted to the institution vide dated 24.08.2010.

- **2. AND WHEREAS,** on promulgation of NCTE Regulations, 2014, the institution had submitted affidavit dated 19.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 22.05.2015 for conducting M.Ed. Programme of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 397^{th} meeting held on $25^{th}-26^{th}$ March 2021 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Cause Notice was issued to the institution on 08.04.2021. The institution has not submitted reply till date.
- **4. AND WHEREAS,** the SRC in its 403rd Meeting held on 18th& 19th October, 2021 consider the matter for non-submission of reply to Final Show Cause Notice and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN) on 08.04.2021. The institution failed to submit reply to the Final Show Cause Notice.

Hence, the Committee decided to withdraw the recognition granted to Nadar Sarswathi College of Education, Vadapudupatti, Annanji Post, Theni District, Tamilnadu-625531 for conducting M.Ed. programme with effect from the academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above".

5. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition Nadar Sarswathi College of Education, Vadapudupatti, Annanji Post, Theni District, Tamilnadu-625531 run by Theni Melapettai Hindu Nadar Uravinmurai Trust, No.1100, Periyakulam Road, Theni District-625531, TamilNadu for conducting M.Ed. programme of two years duration with an annual intake of 50 students (one unit) with effect from the academic session i.e., 2021-2022 onwards.

5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

6. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
