WHEREAS, the recognition was granted to the institution namely Sri Prakash College of Physical Education, Plot No.121, 122/2B, 126/2A, NH5 Street, Plpuram Village, Namavaram (B.P.O), Payakaraopeta Taluk, Visakhapatnam District-531126, Andhra Pradesh run by Sri Prakash Educational Society, Plot No.121, 122/B, 126/2A, NH-5 Road, Plpuram Village, Namayaram (B.P.O), Payakaraopeta Taluk, Visakhapatnam Districtvide SRC (NCTE) order No. F.No.SRCAPP99/B.P.Ed/AP/2013-531126, Andhra Pradesh 14/57402 dated 03.03.2014 for conducting Secondary B.P.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2014-15.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 19.01.2015 for its willingness for adherence of provisions of new Regulations. a revised provisional recognition order was issued to the institution on 19.05.2015 for conducting B.P.Ed. programme of two years duration with an annual intake of 100 (two sections of 50 students each) from the academic session 2015-16.

AND WHEREAS, The management vide letter dated 14.09.2021 submitted written representation for closing of the institution The SRC in its 403rd meeting held during 18th - 19th October, 2021 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee agreed to close down the institution as requested by the society vide letter dated 14.09.2021 by withdrawing the recognition granted to Sri Prakash College of Physical Education, Plot No.121, 122/2B, 126/2A, NH5 Street, Namavaram BPO, Payakaraopeta Taluk & City, Andhra Pradesh for conducting B.P.Ed. Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2021-2022.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in this meeting."

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Sri Prakash College of Physical Education, Plot No.121, 122/2B, 126/2A, NH5 Street, Namavaram BPO, Payakaraopeta Taluk & City, Andhra Pradesh for conducting B.P.Ed. programme of two year

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
