WITHDRAWAL ORDER**

WHEREAS, the recognition was granted to the institution namely, **Niveditha College of Elementary Teacher Education, Plot No. 276/U, Street No.22, Kothakota Village and post, Kothakota Taluk and Town, Mahbubnagar District, Pin-509381, Andhra Pradesh** vide SRC vide order no. F.SRCAPP899/D.El.Ed./AP/2012/45641 dt.29.08.2012 for conducting D.El.Ed. course of two-years duration with an annual intake of 50 students from the academic session 2012-2013.

2. **AND WHEREAS**, the institution vide letter dated 12.10.2020 submitted written representation requesting to close the D.El.Ed. programme. The SRC in its 403rd Meeting held on 18th & 19th October, 2021 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

*The Committee agreed to close down the institution as requested by the institution vide dated 19.10.2020 by withdrawing the recognition granted to **Niveditha College of Elementary Education, Plot No:276/U, Street No: 22, Kothakota Village & Taluka And Town, Mahbubnagar District, Pin-509381, Telangana** for conducting **D.El.Ed. Programme** under clause 17(1) of NCTE Act, 1993 from the academic session 2021-2022.*

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in its earlier meeting".

4. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted **Niveditha College of Elementary Education, Plot No:276/U, Street No: 22, Kothakota Village & Taluka And Town, Mahbubnagar District, Pin-509381, Telangana** run by **Niveditha Educational Academy, Plot No.276/U, Street No.22, Kothakota Village and Post, Kothakota Taluk and Town, Mahbubnagar District-509381, Telangana** for conducting **B.Ed. programme** of two years duration with an annual intake of 50 students with effect from the academic session i.e., 2021-2022 onwards.

5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained

pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

6. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
