WHEREAS, the recognition was granted to the institution namely, St. Mary's College of Education, Good Shephered Edun Trust, Annamaduvu, Anthiyur, Erode-638501, TamilNadu was granted recognition vide SRC (NCTE) order no.F.SRC/NCTE/2009/B.ED./RO/12737 dt.15.05.2009 for conducting B.Ed. Course of one year duration with an annual intake of 100 students from the academic session 2009-2010.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution consented to come under new Regulations vide a notarized affidavit dated 27.01.2015 and the provisional revised recognition order was issued on 01.05.2015 to the institution for conducting B.Ed. programme of two years duration with an annual intake of 50 students (one unit) from the academic session 2015-16.
- 3. AND WHERAES, the matter regarding compliance by the institution of the conditions of the revised recognition order was placed before the SRC in its 369th meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institution which have not submitted compliance. Accordingly, a Show Cause Notice was issued to the institution on 16.08.2019. The institution has submitted reply on 13.09.2019.
- **4. AND WHEREAS,** the SRC in its 404th meeting held on 16th 17th November, 2021 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, a Final Show Cause Notice was issued to the institution on 30.09.2021. The institution has submitted reply on 08.12.2021.
- **5. AND WHEREAS**, the SRC in its 406th Meeting of SRC held on 19th January 2022 considered the reply to Final Show Cause Notice and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide letter dated 08.12.2021. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The initial recognition was granted to the institution on the land belongs to Survey Numbers 181/2, 181/3 & 182 (Old S.No. ½). The institution submitted its reply vide letter dt. 08.12.2021 attaching therewith the land documents belongs to Survey Numbers 580/1 (measuring 5 Acres). Change of location without prior approval of SRC, NCTE is in violation of provisions stipulated under clause 8(9) of NCTE Regulations, 2014.
- 2. Other documents such as BCC, building plan, NEC,LUC etc. cannot be relied upon/considered on the face of deficiency in land documents.

- 3. The institution did not submit proof of disbursement of salary to faculty & non-teaching staff through bank account as required under clause 10(2) of NCTE Regulations, 2014.
- 4. The institution did not submit details of administrative and professional staff as required under clause 5.3 of Appendix 4 of NCTE Regulations, 2014.
- 5. The website of the institution is not uploaded with the information required under clauses 7(14)(i), 8(14) and 10(3) of NCTE Regulations, 2014.
- 6. The institution did not submit registration certificate, bye laws etc. related to the managing society / trust.

Hence, the Committee decided to withdraw the recognition granted to St. Mary College of Education, Annamaduvu, Anthiyur, Erode District-638501, TamilNadu for conducting B.Ed. programme with effect from the academic session i.e., 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above".

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition St. Mary College of Education, Annamaduvu, Anthiyur, Erode District-638501, TamilNadu run by Good Shephered Education Trust, Annamaduvu, Anthiyur, Erode District-638501, TamilNadu for conducting B.Ed. Programme of two years duration with an annual intake of (1 unit) 50 students with effect from the academic session i.e., 2022-2023 onwards.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
