### WITHDRAWAL ORDER

WHEREAS, the institution was granted recognition namely Asha College of Education, Plot No. 52/2, Yellapuram Street & Village, Markapuram Post Office, Taluk & City, Prakasam District, Andhra Paradesh-523316 run by Islamia Educational Society, Plot No. 5-155C, Pattabhi Street, Markapuram Village & Post Office, Markapuram Village & Post Office, Markapuram Taluk & City, Prakasam District, Andhra Pradesh – 523316 granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/SRCAPP3060/D.El.Ed/AP/2016/83344 dated 04.04.2016 for conducting D.El.Ed. course of two years duration with an annual intake of 100 students (2 unit) from the academic sessions 2016-2017.

AND WHEREAS, a letter No. RC. No. 359/A/SCERT/2019 dated 29.06.2020 is received from the Commissioner, School Education (FAC), School Education Department, Govt. of Andhra Pradesh on 17.07.2020 recommending therein for de-recognition order in respect of 188 Pvt. D.El.Ed Colleges in A.P. since the said managements of Pvt. D.El.Ed Colleges have made admission into the D.El.Ed Course during academic year 2018-19 on their own in violation of Government orders. Hence, the Committee decided to issue Show Cause Notice to the institution.

AND WHEREAS, as per the decision a Show Cause Notice was issued to the institution on dt. 29.09.2020. Thereafter the institution did not submit aby reply of Show Cause Notice. The matter was placed before the SRC in its 393<sup>rd</sup> meeting wherein the Committee decided to issue Final Show Cause Notice to the institution. Accordingly, a Final Show Cause Notice was issued to the institution on dt. 11.01.2021.

AND WHEREAS, the SRC in its 395<sup>th</sup> Meeting held on 25<sup>th</sup> & 26<sup>th</sup> February 2021 and considered the matter as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

- 1. The Committee in its 386th meeting after perusal of the letter No. R.C. No. 359/A/SCERT/2019 dated 29.6.2020 received from Commissioner, School Education (FAC), School Education Department, Govt. of Andhra Pradesh recommending therein for derecognition order in respect of 188 Pvt. D.El.Ed. colleges in A.P. since the said managements of Pvt. D.El.Ed. colleges have made admission into the D.El.Ed. course during academic year 2018-19 on their own in violation of Government orders decided to issue a Show Cause Notice to all such institutions also asking therein to explain about the observations made by the School Education Department, Govt. of Andhra Pradesh vide letter No. R.C. No. 359/A/SCERT/2019 dated 29.6.2020.
- 2. The Committee noted that due to non-compliance of SCN dated 29.09.2020 for submission of requisite documents to verify infrastructure & instructional facilities a Final Show Cause Notice dated 11.01.2021 was issued to the institution. However, the institution failed to submit the requisite documents as per Final Show Notice dated 11.01.2021.

Hence, the Committee decided to withdraw the recognition granted to Asha College of Education, Plot No. 52/2, Yellapuram Street & Village, Markapuram Post office, Taluk & City, Prakasam District – 523316, Andhra Pradesh for conducting D.El.Ed course with effect from the next academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Asha College of Education, Plot No. 52/2, Yellapuram Street & Village, Markapuram Post office, Taluk & City, Prakasam District — 523316, Andhra Pradesh run by Islamia Educational Society, Plot No. 5-155C, Pattabhi Street, Markapuram Village & Post Office, Markapuram Village & Post Office, Markapuram Village & Post Office, Markapuram Taluk & City, Prakasam District, Andhra Pradesh — 523316 for conducting D.EI.Ed. course of two years duration with an annual intake of 100 students (two basic units) 50 students each for (D.El.Ed) course with effect from the next academic session i.e. 2021-2022 onwards.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website <a href="www.ncte-india.org">www.ncte-india.org</a>, with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
