WHEREAS, the recognition was granted to the institution namely, Andavar College of Education, 125/2a, Poravachery Main Road, Oporavacheri, Nagapattinam-611108, Tamilnadu vide SRC order No. F.SRC/NCTE/2009/B.Ed./RO/14878 dt. 30.07.2009 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2009-2010.

- AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented 2. to come under new Regulations vide a notarized affidavit dated 14.01.2015. A revised provisional recognition order was issued to the institution on 23.03.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.
- AND WHEREAS, the SRC in its 369th meeting held on 28 01.2019 has considered the matter and the Committee decided to issue a Show Cause Notice. Accordingly, a Show Cause Notice was issued to the institution on 10.10.2019. The institution vide letter dated 08.11.2019 has submitted reply in respect of Show Cause Notice.
- AND WHEREAS, the SRC in its 384th meeting held on 12th 13th February 2020 and the Committee decided to issue a Final Show Cause Notice. Accordingly, a Final Show Cause Notice was issued to the institution on 05.03.2020. The institution has submitted reply on 18.09.2020 to Final Show Cause Notice.
- AND WHEREAS, the matter was further considered by the SRC in its 395th meeting held on February 25-26, 2021 and the Committee decided as follows: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee considered the reply submitted by the institution on 18.09.2020 in response to the Final Show Cause Notice. The Committee found the following deficiency:-

1. The institution has not submitted certified copy of Land Documents.

The institution has submitted notarized copy of Building Plan in which Multipurpose 2. Hall not mentioned and approving authority seal in regional language.

The institution has submitted a letter of faculty list Signed by the Registrar, 3. Tamilnadu Teachers Education University. Total faculty approved: 1 Principal + 15 Lecturers vide dated 04.11.2015.

The institution has not submitted latest copy of faculty list duly

approved by afflicting body.

The institution has not submitted "Form A" issued by the respective Bank Manager 4. towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years along with a copy of the FDRs.

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Andavar College of Education, 125/2a, Poravachery Main Road, Oporavacheri, Nagapattinam-611108, Tamilnadu run by Alamelu Ammal Educational Trust, Poravachery, Nagapattinam, Tamilnadu for conducting B.Ed. course of two years duration with an annual intake of 100 students (2 units) w.e.f. the next academic session i.e. 2021-2022 onwards.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
