WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely **Narendra College of Education, Venkatachalapuram Pullambadi, Trichy District – 621711, Tamil Nadu** run by **S. K. B. Educational Trust, Kunnavalam Post Thiruvallur – 631201, Tamil Nadu** vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2006-2007/17555 dt. 31.01.2008 for conducting **Secondary (B.Ed.)** course of one-year duration with an annual intake of 100 students from the academic session 2006-2007.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 10.04.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 27.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, the matter was finally considered by the SRC in its 395th meeting held on 25th-26th February 2021 considered the matter and decided as under:-

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

1. *The Committee noted that due to non-compliance of SCN dated 28.08.2019 for submission of requisite documents to verify infrastructure & instructional facilities a Final Show Cause Notice dated 21.09.2020 was issued to the institution. However the institution failed to submit the requisite documents as per Final Show Notice dated 21.09.2020.*

*Hence, the Committee decided to withdraw the recognition granted to **Narendra College of Education, Makkalasakthi Educational Society, Venkatachalapuram Pullambadi, Trichy District – 621711, Tamil Nadu** for conducting B.Ed course with effect from the next academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."*

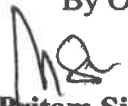
NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **Narendra College of Education, Venkatachalapuram, Thirumalapadi Salai, Trichy – 621711, Tamil Nadu** run by **Makkalasakthi Educational Society, Venkatachalapuram Pullambadi, Trichy District – 621711, Tamil Nadu** for conducting B.Ed. programme of two-year duration with an annual intake of 100 students (2 units) w.e.f. the next academic session i.e., 2021-2022 onwards.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

“If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government.”

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through “online mode” available on NCTE’s website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE’s website.
