WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely **KEC College of Education, Thindiyannam Road, Chinnakangeyanur Pallikondapatti, Thiruvannamalai-606611, Tamilnadu** run **Sri Arunachala Trust, Tiruvannamalai-606611, Tamilnadu** vide SRC order No. F.SRO/NCTE/APS04868/B.Ed./2006-2007/9734 dt. 23.12.2006 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students.

2. **AND WHEREAS**, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 26.03.2015. A revised provisional recognition order was issued to the institution on 30.04.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

3. **AND WHEREAS**, the SRC in its 366th meeting held on 3rd & 4th December 2018 wherein the Committee decided to issue a Show Cause Notice. As per decision of SRC, a Show cause Notice was issued to the institution on 18.12.2018. The institution has not submitted reply the show cause notice till date.

4. **AND WHEREAS**, the SRC in its 380th meeting held on 18th – 19th September, 2019 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 03.10.2019. The institution vide letter dated 05.11.2019 submitted reply to the Final Show Cause Notice.

5. **AND WHEREAS**, the matter was finally considered by the SRC in its 395th meeting held on February 25-26, 2021 and the Committee decided as follows: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:

The Committee decided to write a letter to the Institution asking therein to submit the following documents: -

1. The institution has submitted notarized copy land documents 'Sale Deed' which is in favour of K. Rajan individual person name. Hence the same is not as per provisions of the NCTE Regulations, 2014.
2. The institution has not submitted Land Use Certificate.

3. The institution has submitted photocopy of building plan but not mentioned the multipurpose hall.
4. The institution has submitted photocopy of site which is in regional language.
5. The institution has submitted notarized copy of BCC in favour of K. Rajan individual person name and built-up area different mentioned the building plan.
6. The institution has failed to submit latest faculty list approved by the Affiliating body. As per the old staff list the deficiencies are:
 - (a) The Principal does not have NET/Ph.D.
 - (b) The institution has not appointed performing arts faculty.

Hence, the Committee decided to **withdraw the recognition** granted to **KEC College of Education, Thindiyanam Road, Chinnakangeyanur Pallikondapatti, Thiruvannamalai Tamilnadu** for conducting B.Ed course with effect from the end of the academic session 2021-2022 under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

6. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **KEC College of Education, Thindiyanam Road, Chinnakangeyanur Pallikondapatti, Thiruvannamalai Tamilnadu** run by **Sri Arunachala Trust, Tiruvannamalai-606611, Tamilnadu** for conducting B.Ed. course of two years duration with an annual intake of 100 students (2 units) w.e.f. the next academic session i.e. 2021-2022 onwards.

7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website

www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.

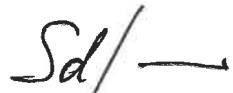
